Description of the land to which the repeal of the designation applies

The Ministerial designation applies to land located at Nerang Street and High Street, Southport.

The land is described as Parish of Nerang, County of Ward, Lot 247 on SP240355 and Lot 9 on SP104024.

The purpose of the designated land prior to this repeal

The land was designated on 29 September 2000 pursuant to the *Integrated Planning Act 1997* (repealed) for the purposes of Community Infrastructure (the Gold Coast Hospital) and described under Schedule 5 as (h) hospitals and associated institutions, and further described as:-

Public health facility, plus support facilities, including commercial and medical services, engineering and maintenance services, teaching and research facilities; staff and public car parking, helipad, accommodation for emergency services and relative accommodation and child care.

The reason for this repeal

The repeal of the Ministerial designation for the Gold Coast Hospital, Nerang Street Southport has been made as a result of the closure the Gold Coast Hospital and the relocation of all hospital services to the new Gold Coast University Hospital, which was opened on 28 September 2013.
