#### Witnesses to applicants signatures

The transfer must be executed as follows:

- For individuals, signatures can be witnessed by any other person, the witness must be 18 years or over.
- For a corporation, the form is signed in accordance with the *Corporations Act 2001*, s127 by: either two directors, or a director and a company secretary, or the sole director who is the sole secretary.
- All applicants must be 18 years or over to hold an Authority.

Be aware that legislative provisions relating to the ability to take fish under the licence becomes the transferee's right, while other responsibilities, for example, logbook compliance and invoice fee payments, remain with the original holder. For further clarification of the responsibilities between parties to the temporary transfer please contact the Department.

#### Company extract

A company extract is a specific document issued by the Australian Securities and Investment Commission which identifies the directors and secretaries of the company. Please note that a certificate of incorporation **is not a company extract**.

### **Information Requirements**

By submitting this form, you acknowledge that you are aware of the current quota, logbook and vessel tracking information requirements for operating in Queensland fisheries.

- Vessel tracking requirements for particular fisheries (e.g. net, line, crab, sea cucumber and trawl) apply;
- Particular fisheries are managed by a quota system. Quota entitlement must be held and quota reporting requirements must be completed when operating in these fisheries (e.g. RQ, shark, etc);

•	Logbooks are required to be completed and submitted for each fishery. Please refer to the logbook directions located in
	the front of your logbook. The logbooks should be passed between the applicants at the time of lodging this application
	or a new logbook will be issued to the transferee if the following box is ticked
