(PROTECTION OF OLD BURLEIGH THEATRE ARCADE) 2021
FOR THE CITY OF GOLD COAST**

Notice is given under the *Planning Act 2016* that on 20 July 2021, the Council of the City of Gold Coast adopted the *Temporary Local Planning Instrument No. 9 (Protection of Old Burleigh Theatre Arcade) 2021* for the City of Gold Coast.

The *Temporary Local Planning Instrument No. 9 (Protection of Old Burleigh Theatre Arcade) 2021* has effect from 30 July 2021 and will cease to have effect on 30 July 2023, unless repealed sooner.

The purpose and general effect of the *Temporary Local Planning Instrument No. 9 (Protection of Old Burleigh Theatre Arcade) 2021* is to ensure the protection of this significant local heritage place and landmark by:

- (a) triggering impact assessment for any removal, demolition or partial demolition of the existing building located on Lot 1 on RP72012;
- (b) identifying land described as Lot 1 on RP72012 on the Heritage overlay map of the City Plan; and
- (c) affecting the operation of the City Plan by amending and adding assessment benchmarks in the Heritage overlay code to ensure that the cultural heritage significance of the Old Burleigh Theatre Arcade is protected and development is appropriately designed and sited to respond to the building's contextual cultural significance having regard to character, setting and appearance of this building.

The *Temporary Local Planning Instrument No. 9 (Protection of Old Burleigh Theatre Arcade) 2021* applies assessment provisions to development over Lot 1 on RP72012 and applies in addition to the current provisions of the City Plan. If the City Plan is inconsistent with this temporary local planning instrument, this temporary local planning instrument—

- (a) prevails to the extent of the inconsistency; and
- (b) has effect in place of the City Plan, but only to the extent of the inconsistency.

- (a) will be available for inspection at the Nerang Administration Centre; and
