Commissions of Inquiry Act 1950

#### Commissions of Inquiry Order (No.3) 2022

#### Short title

This Order in Council may be cited as the Commissions of Inquiry Order (No.3) 2022.

#### Commencement

This Order in Council commences on Monday 13 June 2022.

#### **Appointment of Commission**

- UNDER the provisions of the Commissions of Inquiry Act 1950, the Governor in Council hereby appoints Walter Sofronoff QC, as Commissioner, from Monday 13 June 2022, to make full and careful inquiry in an open and independent manner with respect to:
  - whether the methods, systems and processes used by the Queensland Police Service and the Forensic and Scientific Services for forensic Deoxyribonucleic Acid (DNA) collection, testing and analysis are, and have been, reliable, conducted in accordance with best international practice, and result in, and have resulted in, accurate reporting of the presence of DNA in samples submitted for testing and accurate matching of DNA samples; and,
  - whether, if such methods, systems or processes are not, or have not been, reliable, or conducted in accordance with best international practice, or do not result, or have not resulted, in accurate reporting or accurate matching, the reasons for any such failure.

### Commission to report and make recommendations

AND directs that the Commissioner make full and faithful report and recommendations on the aforesaid subject matter of the inquiry, including an executive summary.

- AND directs that the Report be transmitted to the Honourable the Premier and Minister for the Olympics, the Honourable Minister for Health and Ambulance Services and the Honourable Attorney-General and Minister for Justice, Minister for Women and Minister for the Prevention of Domestic and Family Violence.
- AND directs that the final report be provided within six months of commencement of the Commission, that is, by 13 December 2022, AND that the Commissioner will determine whether an interim report is provided before that date.

### **Application of Act**

Pursuant to section 4(2) of the Commissions of Inquiry Act 1950, it is declared that all of the provisions of the Commissions of Inquiry Act 1950 shall be applicable for the purposes of this inquiry, except for section 19C (Authority to use listening devices).

#### **Conduct of inquiry**

The Commission may receive submissions from relevant individuals and entities and hold public and private hearings in such a manner and in such locations as determined by the Commissioner, as appropriate and convenient and in a way that protects and promotes the rights protected under the Human Rights Act 2019.

## Queensland Competition Authority Act 1997 Section 36 (2)

#### **DECISION**

#### 1. The Decision

Under section 36(2) of the *Queensland Competition Authority Act 1997* (the Act), I accept without qualification recommendations 1 and 3 in the Queensland Competition Authority's (QCA) titled *Final Report – Sequenter Bulk Water Price Review 2022-26* (the Report) and I reject without qualification recommendation 2 in the Report.

## 2. Background

The supply of bulk water by the Queensland Bulk Water Supply Authority (Seqwater) is declared a monopoly business activity under the Act.

On 16 June 2021, I, as the Minister administering the Act, referred the monopoly business activity of bulk water supply by Seqwater to the QCA for an investigation about the pricing practices relating to that activity under section 23(1) of the Act (the referral notice). The objective of the referral notice was for the QCA to make recommendations about the State bulk water prices for Seqwater in the following local government areas for the period of 1 July 2022 to 30 June 2026 (Prices).

Brisbane Logan Scenic Rim
Gold Coast Moreton Bay Somerset
Ipswich Noosa Sunshine Coast

Lockyer Valley Redland

The QCA provided the Report to me on 31 March 2022 under section 30 of the Act. The Report made three recommendations in relation to Prices.

As Minister administering the Act, under section 36 of the Act I am required to make a decision about the QCA's recommendations contained in the Report, as a report relating to a monopoly business activity that is a government business activity, other than a significant business activity.

I am required by section 36(3) of the Act to have regard to water pricing determinations before making a decision under section 36(2).

#### 3. Consultation with stakeholders

In undertaking its investigation, I note that the QCA has:

- sought submissions from stakeholders and interested parties, including Seqwater; and
- provided responses in the Report to issues raised by stakeholders.

# 4. Findings on material questions of fact and evidence and material on which this decision is based

The QCA has not previously made any water pricing determinations referred to in section 36(3) of the Act.

In making my decision under section 36(2) of the Act I have considered the evidence and materials in the Report and findings on material questions of fact made by the QCA in the Report.

### 5. Reasons for the decision

The Price Policy Objective was given effect in the referral notice. The QCA has recommended Prices consistent with the referral notice and the QCA's obligations under the Act. On this basis, I accept the costing methodologies utilised by the QCA as being consistent with the Price Policy Objective.

#### Recommendation 1

The QCA recommend the following Prices:

- 1 July 2022 to 30 June 2023: \$3.301 per kilolitre;
- 1 July 2023 to 30 June 2024: \$3.371 per kilolitre;
- 1 July 2024 to 30 June 2025: \$3.444 per kilolitre; and
- 1 July 2025 to 30 June 2026: \$3.517 per kilolitre.

I accept Recommendation 1 based on the QCA's assessment in Chapters 8, 9, 10 and 12 of the Report.

## Recommendation 2

The QCA recommend the following drought allowances:

- 1 July 2022 to 30 June 2023: \$0.405 per kilolitre;
- 1 July 2023 to 30 June 2024: \$0.414 per kilolitre;
- 1 July 2024 to 30 June 2025: \$0.424 per kilolitre; and
- 1 July 2025 to 30 June 2026: \$0.435 per kilolitre.

The drought allowances recommended by the QCA could be applied in addition to the Prices that would apply under normal operating conditions to deal with the higher costs of operating in drought conditions. Sequater is no longer operating under drought conditions and given current dam levels, Sequater is unlikely to incur drought response costs in the near term, as stated by the QCA in section 12.1 of the Report. On this basis, I reject recommendation 2.

Recommendation 3

The QCA recommend that future review events should be defined in accordance with the table on page 107 of the Report. I accept Recommendation 3 based on the QCA's assessment in section 12.2 of the Report.

## 6. Human Rights

Section 58(1) of the *Human Rights Act 2019* (HR Act) makes it unlawful for a public entity:

- (a) to act or make a decision in a way that is not compatible with human rights; or
- (b) in making a decision, to fail to give proper consideration to a human right relevant to the decision.

Section 58(5) of the HR Act provides that, for section 58(1)(b), giving proper consideration to a human right in making a decision includes, but is not limited to:

- (a) identifying the human rights that may be affected by the decision; and
- (b) considering whether the decision would be compatible with human rights.

I accept that the threshold for engaging a human right is low, and that for this purpose human rights must be construed in the broadest possible way. In accordance with section 58(1) of the HR Act, I have considered whether the decision to accept or reject the recommendations made by the QCA in the Report would be compatible with human rights.

I consider that the decision to accept or reject the QCA's recommendations under the QCA Act does not affect the human rights of any individual. I therefore consider that the decision is compatible with human rights.

## 7. Definitions

"Price Policy Objective" means the Government's policy objective that Prices should recover the prudent and efficient costs of providing bulk water supply services and repay price path debt by 2027-28, under normal operating conditions.
