Bessie Richards: H/C woman about 20 years absconded from service in Brisbane. Small amount to her credit and wants to buy winder clothing to return to service.

Janey Logan: absconded from service in Brisbane, been in Ipswich Hospital for over a month with "*house-maid's keen.*" Wants some of her money and statement of her bank. She is legally married.

Sandy and his wife Sarah: couple were employed by Mr Joyce at Beaudesert and deserted walking via Boonah to Mission. Want to get back to Barambah and take Violet with them.

Violet: young Aboriginal who was at service with Mr Joyce at Beaudesert and deserted with her husband who is now in Brisbane Hospital. She wants to return to Barambah with Sandy and Sarah where her friends are. Unable to walk owing to swollen ankle, injured on 17.3.1906 returning from Sports at Bundamba. Sarah told could not go back until Violet's foot bathed.

Esther McDonald: intelligent H/C girl about 13 years of age. Wants to leave camp and go to employment. Committed under *Reformatories Act*. Suitable situation should be found for her.

Arthur: absconded some time ago and Minister's Order secured but now quite contented.

Paddy: boy according to *Truth* superintendent supposed to have kicked in nose. No trace of wound now. Boy is almost quite white.

Marriages: all marriages are legal, most celebrated by Reverend Peter Robertson. Janey Logan and Jerriba at Mission and Mollie Bawn at Woodenbah, NSW. [Indexer's note: Mollie Brown.]

Willie Brown: asked permission for his children to attend Esk State School. Called at office advising he was living at Mount Hallon and wanted return to Deebing Creek so his two children could attend school. Mr Foots says be glad to have back.

They ran the first day but on the second day a Sergeant of the Police notified that the Aborigines would be allowed to compete further; Isaacs and Morgan won their heats so a serious loss will be sustained if they are not permitted to race. States that in first week of December 1904 Sharpe interviewed Dr Roth who said the blacks might run if the gins were not brought into town or admitted to the grounds. Seventh Handicap to be run and Aborigines and half-castes ran in them all.
- Memorandum dated 12.3.1907 (**07/517**) to the Secretary, Deebing Creek Mission Station from Chief Protector of Aborigines regarding Freddy Beckett H/C applying for a railway pass from Brisbane to Ipswich, to return from the *Seventh Queensland Hundred*. Memo goes on to state this Office intends to exert every effort to obliterate the practice of natives attending or running in such meetings.

Mrs Black is very old feeble woman between 60 and 70 years of age, and can't work and has no relatives living. Supports herself and little girl by begging from farmers and other people living locally. She is a very old identity and a native of the Logan. Considers her a deserving case for State assistance. Recommends rations be granted. She is living within three miles of the place where she was born. [Indexer's note: handwritten notes on this letter indicate rations were granted and instructions given to find out if any relatives at Deebing Creek can contribute to her maintenance.]

- Letter dated 18.12.1914 (**14/10472**) from Peter Robertson, Deebing Creek Mission to Home Office regarding if satisfied with progress of works promise of grant of £200, accounts already in.
- Letter dated 26.10.1914 (**14/78**) from Chief Protector of Aborigines to Under Secretary advising the proposed grant of £200 for Deebing Creek Mission to stand over for the present. Outlines work being done and acquisition of a farm, production, and attached copy of returns money received towards buildings since establishment in 1892.
- Letter dated 23.9.1914 (**14/2662**) from Peter Robertson, Deebing Creek Mission to the Home Secretary asking for a grant to cover cost of removing buildings 9 miles to Purga. Outlines work done to date, production and labour.
- Extract from Deebing Creek Annual Report 1913 noting work on farm and connected with the home continued but not success hoped for, due to fact that it is long distance from home. Suggests moving residence and school nearer to land under cultivation. Only difficulty is expense to remove buildings.
- Undated Memo of Grants to Missions for Initial Expenditure – covers Mapoon, Deebing Creek, Cape Bedford and Yarrabah.
- Letter dated 13.10.1913 (**13/11494**) from W.H. Foote, Committee, Deebing Creek Mission to the Home Secretary asking to be notified when Minister will inspect Deebing Creek Mission.

12.10.1915. Memorandum from Chief Protector of Aborigines to Superintendent, Deebing Creek advising no need to put men obtaining sleeper blocks under agreement if they are not employed by anyone.

- Letter dated 16.10.1915 (**15/3076**) from Robert Morrison, Superintendent, Deebing Creek to Chief Protector of Aborigines asking if it is necessary to put four married men obtaining sleepers for the government under agreement. Their wives and families live on the Mission and their children attend the school.

22.3.1915. Letter from R. Morrison, Superintendent, Deebing Creek Mission to CPA, Brisbane re Tommy McGrath. Tommy was discharged from Ipswich Hospital on 22.3.1915. Mentions little girl, Eva McGrath, still in hospital but improving, and the boy, Jack McGrath, improving but needs special care for chest trouble.

- Memorandum dated 19.3.1915 (**15/832**) from Chief Protector of Aborigines to Superintendent Deebing Creek re receipt of letter advising of serious illness of Tommy McGrath and family.
- Letter dated 9.3.1915 (**15/709**) from R. Morrison, Superintendent, Deebing Creek Mission to CPA, Brisbane re serious ill-health of the family of Tom McGrath and death of his youngest child. Notes Tom McGrath and family been sick since arriving at the Mission. Tommy and youngest girl sent to Ipswich hospital and six week old baby died last night, the oldest boy now the only boy but he is also unwell. Tom McGrath is referred to as the "*man sent from Inglewood who lost his wife.*"
- Letter dated 19.2.1915 (**15/530**) from Inspector of Police, Toowoomba forwarded to CPA re Voucher for rations supplied [Tommy] McGrath and family prior to their removal from Inglewood to Deebing Creek Mission.
- Letter dated 11.2.1915 (**15/530**) from Inspector of Police, Toowoomba forwarded to CPA re letter from Mrs E. Rutledge of Gore in reference to Tommy McGrath infant child. Mrs Rutledge becoming ill and finding it difficult to continue caring for Tommy McGrath's baby. Mentions the other 3 children and father are still at Inglewood Station.
- Letter dated 11.2.1915 from Mrs E. Rutledge, The Ranch, Gore to Sergeant Dyer, Inglewood [Inspector of Police, Toowoomba] stating she

was becoming ill from lack of sleep from looking after [Tommy McGrath's] infant son. Could other arrangements be made for the baby's care.

- Letter dated 5.2.1915 from Inspector of Police, Toowoomba relative to death of Vera McGrath on 4.2.1915 at Gore. Mr Bougoure of Gore wired that Tommy McGrath wife had died. Tommy McGrath's hut about one mile from Gore Siding. Sergeant Dyer examined deceased then she was "*buried the body nearby.*" Interviewed Mr P. Rutledge, Justice of the Peace and owner of selection at Gore. Rutledge explained deceased was confined on Thursday 20 January of a son and was doing well until Thursday 4 February when complained of being weak and died at 7.00pm. Interviewed Mr D. Bougoure. Manager of Dungorm where Tommy McGrath was employed. Bougoure of the opinion deceased affected by excessive heat. Interviews Mrs Ison and Mrs Rutledge, both of whom had visited deceased shortly after having her baby and just before she died, and Miss Hart, school teacher who had visited deceased twice before she passed away. Interviewed Tommy McGrath, husband of deceased, and he noted that deceased had a child on Thursday week and appeared to be doing well until the day she died when she had complained about the heat and being weak. No suspicious circumstances surrounding her death. Noted Mrs Rutledge kindly looking after the baby until such time as arrangements can be made. Sergeant brought Tommy McGrath and 3 children in by train to Inglewood, where camped in the stable of the police quarters. Father is cooking and looking after children – Sarah 8 years, Jack 6 years, Eva 2 years.
- Telegram dated 7 February 1915 **(15/476)** "*Tommy McGrath aboriginal and four children left Sydney mail arrive Ipswich eight pm*" [Indexers note: handwritten next to "*for Deebing Ck*"]
- Letter dated 9.2.1915 **(15/478)** from R. Morrison, Aboriginal Home Purga re accepting the Aboriginal man [Tommy McGrath] who lost his wife at Inglewood and their 4 children at Deebing Creek.
- Letter dated 8.2.1915 **(15/232)** Memorandum from Chief Protector of Aborigines to Superintendent, Deebing Creek Mission asking for a quick reply on whether can accept an Aboriginal man [Tommy McGrath] from Inglewood and whose wife recently died and their 4 children – 8, 6 and 4 years and a baby a week old.

Letter 15/3365 [Top number]

22.11.1915. Memo from Deputy Chief Protector of Aborigines to Protector of Aborigines Maryborough re application of half-caste Frank Smith for exemption. Advising that boy's mother and family are on Deebing Creek Mission and not considered advisable or in his interests to recommend exemption.

- Letter dated 2.11.1915 **(15/3222)** from R. Morrison, Superintendent, Deebing Creek to CPA, Brisbane re exemption for Frank Smith. Notes Smith came to Mission on 10 November 1914 and left on 9 month agreement with Mr Fitzgerald of Moongool Station, Yeulba on 17 August 1915 and made his home on Mission until 30 August 1915 when he cleared out to Nanango. Believes mother is a bad influence on him and can't recommend exemption.

- Letter dated 2.11.1915 from Robert Morrison, Superintendent, Purga Aboriginal Home to Chief Protector of Aborigines re Frank Smith's exemption. Notes no need for Frank to be exempt as Frank's mother "[Lizzie Smith who absconded from the Mission on the 20th day of September 1915]" could get rations from the Mission. States that Lizzie has been sulking since she came back from jail on 30 September and sends her mother out begging for food from neighbours. Mentions Lizzie had two children with her also.
- Letter dated 22.10.1915 (15/3137) from Sergeant, Nanango forwarded to Chief Protector of Aborigines relative to half-caste Frank Smith asking to be allowed to work without restraint. Notes Frank practically reared on Nanango Station amongst white men and was staying there after coming out of hospital 5 or 6 weeks before. Steady boy and recommend allow him to work without restraint.
- Letter dated 8.10.1915 (15/3137) from Frank Smith to Mr Lewis, Brisbane requesting he be allowed to work without restraint. Mentions he had gone to Nanango Station, where he had been before, when he came out of hospital and was now feeling fairly strong. His mother is at Deebing Creek and she does not get any food except what she buys so he will have to assist to keep the two younger children.

26.7.1915. Letter from R. Woolley to Chief Protector of Aborigines apologising for failure to send in last quarterly return.

Letter 15/78

18.1.1915. Letter from W.H Foote to Deputy Chief Protector of Aborigines acknowledging receipt of £200.

Letter 15/1129

14.4.1915. Letter from Chief Protector of Aborigines to Under Secretary attaching an application from Deebing Creek for admission of nine orphan children removed under Minister's order to Industrial School. Notes eight of the children were removed in November 1914.

Letter 15/3745

8.4.1915. Letter from W.H. Foote to Chief Protector of Aborigines noting no money has been received since December 1914 for the fourteen children in the Industrial School. Asks for supply of vouchers.

Letter 19/3745

18.2. 1915. Letter from R. Morrison to Chief Protector of Aborigines applying for grant towards maintenance of nine children now at Deebing Creek. Lists committed children as:
