### F. Applicant's declaration

in the State of Queensland, do hereby declare that:

1. I am a primary producer who normally spends more than 50 per cent of my labour on, and derives more than 50 per cent of my gross income from, a primary production enterprise.
2. I am a property owner, sharefarmer or lessee in the grazing industry (beef cattle, sheep, dairy cattle, goats, deer or horses that are not normally handfed).
3. My property is/was within a state drought-declared area or has/had a current Individually Droughted Property declaration on the date the transport occurred.
4. No livestock have been introduced onto this property while it is drought-declared or in the 3 month period prior to this drought declaration (includes stock taken on for agistment). If livestock have been introduced, it is in accordance with the eligibility criteria as outlined in the *Transport of fodder freight subsidy* guidelines.
5. The fodder is used to feed grazing livestock permanently residing on the property.
6. The total amount of fodder purchased and on hand does not exceed the minimum amount needed to supplementary feed drought-affected livestock for 3 months.
7. The distance claimed for the transport of the fodder was the shortest practicable route.
8. The costs of the fodder described in the claim (page 4 of this form) and the cost of freight for transport of the fodder have been paid in their entirety and the necessary tax invoices are attached.
9. I have not received a Drought Preparedness Grant, a Drought Ready and Recovery Loan or an Emergency Drought Loan through the Queensland Rural and Industry Development Authority (QRIDA) and understand the once I access these assistance measures through QRIDA I will no longer be eligible for DRAS.
10. I understand that by receiving a payment through DRAS, I will not be able to access the Drought Preparedness Grant, the Drought Ready and Recovery Loan or the Emergency Drought Loan through QRIDA in the same financial year as the DRAS payment has been paid.
11. In order to assess my claim and make an informed decision on my eligibility for drought assistance, I understand and agree that DAF may need to consult with QRIDA to verify any assistance previously received through QRIDA that may impact on my eligibility for DRAS.
12. In order to assess my claim and make an informed decision on my eligibility for drought assistance, DAF will need to confirm the details provided on this form with the details previously provided as a Registered Biosecurity Entity. These details will not be accessed or used for any other purpose other than to assist in assessing this claim. I consent to authorised officers accessing and confirming my details in the Biosecurity Entity Registration System.
13. I agree to provide National Livestock Identification System (NLIS) data for the time period relevant to my application if requested. I understand that this information will only be used for assessment and compliance purposes related to processing and managing my application.
14. I understand that any applications submitted under the Drought Relief Assistance Scheme may be subject to audit by DAF or its agents in order to determine compliance with scheme guidelines. By signing this declaration, I understand that I may be asked to provide further information in regards to my application and/or the material submitted with my application and that I may be requested to allow a property inspection by DAF as part of an audit process to determine compliance with scheme guidelines.
15. The information I have provided in this application and in supporting documentation is, to the best of my knowledge, true and accurate. I understand that providing inaccurate, untrue or misleading information may be a breach of criminal law, for which serious penalties may apply. I also understand that if any information I have provided in the application or supporting documentation is found to be inaccurate, untrue or misleading, legal action may be taken against me, including action to recover the subsidy.

As a general guide, the following weights are applied to hay purchases:

**Small rectangular bales**

4' x 1' 6" x 1' 3" (1.2 m x 0.45 m x 0.375 m) = 20–25 kg (stubble/straw lucerne)

**Large rectangular bales**

8' x 3' x 2' (2.4 m x 0.9 m x 0.6 m) = 230–300 kg, 3–4 bales = 1 tonne  
 8' x 4' x 3' (2.4 m x 1.2 m x 0.9 m) = 480–500 kg, 2 bales = 1 tonne  
 8' x 4' x 4' (2.4 m x 1.2 m x 1.2 m) = 650–750 kg, 1.3–1.5 bales = 1 tonne

**Round bales**

4' x 4' (1.2 m x 1.2 m) = 250 kg, 4 bales = 1 tonne  
 5' x 4' (1.5 m x 1.2 m) = 480–500 kg, 2 bales = 1 tonne  
 5' x 5' (1.5 m x 1.5 m) = 650–750 kg, 1.3–1.5 bales = 1 tonne
