Research Guide to Executive Council minute records at Queensland State Archives

Queensland State Archives (QSA) is the official repository for Queensland Government records selected for permanent retention because of their continuing value. The archived public records are from state government departments, state courts, local government authorities and statutory authorities. The records are in our facility at <a href="Runcorn">Runcorn</a>, <a href="Britohne-Brisbane">Brisbane</a>, and open records are available for viewing in the Reading Room, free-of-charge.

Queensland State Archives holds records of the Executive Council of Queensland, from the first Executive Council meeting minutes on 12 December 1859. Access to records less than 30 years old is restricted.

The role of the Executive Council is to advise and assist the Governor in the exercise of his powers. Members of the Executive Council are Ministers of Parliament. Executive Council meetings are presided over by the Governor or a member appointed by the Governor.

The Executive Council minutes record matters considered by Cabinet which require formal approval and signature by the Governor. These include Commissions, Proclamations, Orders in Council, regulations, appointments of Judges, Magistrates and senior public service positions, appointments to statutory authorities and boards, approval of certain government expenditure, disposition of Crown Land, compulsory land acquisition, authorisation of loans and borrowings, pardons for prisoners, and other matters for which the Governor is required by law to take executive action.

The main finding aid for records held at QSA is the <u>Queensland State Archives' online catalogue</u> (known as ArchivesSearch).

### Executive Council of Queensland indexes and minutes

#### **Executive Council Minutes**

12/12/1859 - 31/12/2014 \$5251

The minutes of proceedings of the Executive Council include the yearly number, meeting place, date, those present, the Governor's recommendations, the recommended Council advice, and the immediate action. The minutes are signed as read and confirmed by the Governor. When the minute was published in the *Queensland Government Gazette*, the date of the notice is given. The letter number of any previous correspondence on the subject is shown on the top left corner. The date of any subsequent action taken by the Department is also given. There are remarks including 'Crown Solicitor informed', 'Confirmed', 'Immediate action'. The minutes include staff appointments, departmental administrative arrangements including changes to organisational structure, and matters relevant to the Acts for which the department is responsible. This series consists of loose file copies of Executive Council minutes. The entries in these copies are essentially the same as those in the official Executive Council minutes books, but some file copies contain documents such as despatches not in the minute books.

### Other Executive Council minutes

For the different government departments, the usual practice was for each Minister to present recommendations from their own Department to the Executive Council. Each recommendation would then either be approved and embodied in an Executive Council minute or disapproved. A copy of the minute would be sent to the Minister for the necessary action.

Other series of Executive Council minutes listed below consist of copies of minutes of proceedings of the Executive Council.

This series is the minutes of the Executive Council referred for attention to the Secretary for Public Lands. Minutes include the constitution of bore water supply areas and amendments to boundaries of same, appointment of members of Bore Water Supply Boards; approval of by-laws of water authorities, and authorising water authorities to borrow money.

### **Executive Council Minutes – Justice Department** 1/1/1866 - 31/12/1978 S6406

### **Executive Council Minutes – Lands Department** Circa 1/1/1925 - 31/12/1939 S13885

The majority of the documents consist of a cover sheet with a recommendation and a draft copy of the proposed Queensland Government Gazette notice, and sometimes maps. The Lands Department usually had between 20 and 30 items for the weekly meetings of the Executive Council. Matters include the opening of land for lease or sale, resumptions, reserves, the issue of leases and deeds, opening and closing of roads, appointment of trustees and staff and legislative responsibilities of the department.

# Executive Council Minutes – Library Board of Queensland 14/1/1958 – 30/1/1968 S7159

This series relates specifically to expenditure from the Library Board's Trust Fund in pursuance of the *Libraries Acts*, 1943-1949. Expenditure was incurred by way of payments of subsidies on amounts expended by local bodies and grants to approved organisations.

## Minutes of Executive Council Meeting 14 Jan 1863 - Office of the Governor of Queensland \$12766

Typewritten copies of the minutes of a meeting of the Executive Council held on the 14 January 1863. The purpose of the meeting was to establish procedures to be followed prior to Executive Council meetings to ensure that Ministers were cognisant of all business to be brought before the Council.

Minutes are described as Section A or Section B according to subject, e.g. Section A is about other Departments, Public Service Regulations, Public Service List, private work, appeals, salary variations; Section B is about the Department, staff, allowances and superannuation benefits and sick leave. # Executive Council Minutes – State Electricity Commission/Queensland Electricity Commission 28/4/1938 – 15/12/1994 \$534

Minutes are a record of the decisions and recommendations passed down by the Council, and notified in the Government Gazette. Matters include the Constitution of Regional Electricity Boards and other Electricity Suppliers; appointments and resignations of members of Electricity Boards; authorisation of loans; industry and project contracts and disputes; legislative and regulatory amendments, draft Orders-in-Council proclaiming decisions, explanatory memos from the Minister on behalf of the Commissioner, schedules, power supply contracts, establishment of stations and sub-stations, employment conditions, procedures, expenditure, loans.

The series consists mainly of drafts of letters, despatches and proclamations prepared by officers of the Colonial Secretary's Office for signature by the Governor or the Premier. It also includes some copies of letters received, and of Executive Council minutes.

### Register of matters for consideration by the Executive Council

16/12/1885 - 14/7/1890

This series consists of registers of matters to be put forward by the Colonial Secretary or the Chief Secretary for consideration by the Executive Council. Each entry is dated the day before the Executive Council met and the matters referred to in each entry appear in the minutes of the Executive Council meeting of the following day. The entries refer mainly to appointments, resignations, public holidays, transfer or remission of prisoners, the issue of patents, local authorities, licences. The registers give the date and a brief description of the subject to be raised at Executive Council minutes the following day/session.

#### **Letterbooks - Outwards Correspondence**

These letterbooks contain copies of letters sent by the Clerk of the Council mostly to Executive Council Ministers and include covering letters for Executive Council minutes about matters approved and forwarded to Ministers, authorisation for expenditure, letters to Judges about sentences, and letters to private individuals.

This series of miscellaneous papers includes inwards correspondence, copies of minutes of the proceedings of the Executive Council, the order of proceedings at the opening of Parliament and papers relating to Executive Council members Oath of Office and Secrecy.

The series is arranged in part by top numbered batches (referring to the earlier system of top numbering correspondence) and in part by straight batch numbers. There is no cross referencing between top numbers and batch numbers in most of this series.
