Research Guide to records about Australian South Sea Islander peoples at Queensland State Archives Australian South Sea Islanders are advised that the archival collection contains names and images of people who have passed away.

Some terms in this guide, and in the archival records, reflect the period in which the records were created – they may be offensive and derogatory, and are unacceptable today.

Queensland State Archives is the official repository for Queensland Government records selected for permanent retention because of their continuing value. The records are in our facility at <u>Runcorn, Brisbane</u>, and open records are available for viewing in the Reading Room, free-of-charge.

The Queensland State Archives holds many records about South Sea Islanders. This guide lists records about Australian South Sea Islander people from their first arrivals in the early 1860s to their subsequent deportation or settlement, particularly in the first two decades of 1900s. These records cover the areas of immigration, employment (indentured labour), returns, exemptions, education, and settlement of the Australian South Sea Islander people in Queensland. They include passenger lists, lists of labourers, registers of agreements and exemption from deportation, and correspondence about these matters.

This guide also includes a list of State and Commonwealth legislation.

Details entered for each Islander include number on inward passenger list, name, gender, island, ship, date of agreement and expiration, wages, return passage when paid and by whom, and general remarks (deaths, returns home, re-engaged etc).

These ledgers record wages paid to Islanders employed in the Childers district. Details given include name, island, date of arrival in Queensland, employer's name and address and number, bank and passbook details (e.g. passbook number, date, transaction, C.B. number, deposits, withdrawals, balance, and remarks).

Under the heading 'Particulars', details for each entry include number, ship, port of arrival (from 1878, to Maryborough only), date of arrival; under the headings for each island group (Loyalty, New Hebrides, Banks, Solomons, other Islands), details for each entry include the name of island and number of islanders. Summary totals for males and females for each year are also recorded.

This register records date of arrival, ship, name of government agent; lists the Islanders on board each ship with details including number, name, island, name of employer, residence, and date of agreement. Also included are total numbers of Islanders on each ship, dated and signed by the Inspector of Pacific Islanders, Maryborough.

This register, <u>ITM18834</u> in S13177, was kept by the Inspector of Pacific Islanders, Maryborough, records the departure of vessels returning Pacific Islanders to their homes under the *Polynesian Labourers Act 1868* and the *Pacific Island Labourers Act 1880*. Under the heading 'Particulars', details for each entry include number, ship, port of departure (from 1877, from Maryborough only), and date of sailing; under the headings for each island group (Loyalty, New Hebrides, Banks, Solomons, Other Islands), details for each entry include island and the number of islanders (except for some entries for 1880 and for 1881 for which totals only are entered). Summary totals for males and females and for each year are also recorded.

Registers in S13184 were kept by the Inspector of Pacific Islanders, Maryborough, record the employment of Pacific Islanders ((Polynesians, South Sea Islanders) as required under the *Polynesian Labourers Act 1868* and the *Pacific Island Labourers Act 1880*. Register titles and details entered in the registers vary over time according to the Act under which the registers were kept, but headings for each employer include name of employer, name of plantation and district. Details entered for each Islander include number, name, island, date of arrival or agreement, expiration of agreement, ship, date when due for return and remarks including transfers, deaths, returns etc.

These signed and witnessed memoranda of agreement between employers and Islanders set out the conditions of employment of labourers including wages and rations, provision of accommodation and payment of return passages. On the back of an agreement each Islander's details are included under the following headings: name and mark, island, village, wages, ship, date, first employer, last legal employer, by whom passage paid and when.

This register, <u>ITM18855</u> in S13193, was kept by the Inspector of Pacific Islanders, provides a monthly record of the causes and number of deaths of labourers. Yearly entries include the names of the diseases (dysentery,

consumption, general debility, accidents), and the number of deaths for each disease per month. Yearly totals are also included.

Under Per Contra, details also include withdrawal paid to islanders and witness to payment. Throughout the book quarterly Savings Bank balances are also included.

This ledger records deposits and withdrawals in Pacific Islanders' Savings Bank Accounts kept by the Inspector of Pacific Islanders, Maryborough. Details entered for each Islander include passbook number, name, ex (name of ship), and name and address of employer. These entries are followed by spreadsheet columns for recording bank transactions with ledger details for each entry including the date, transaction (usually 'Interest'), Cash Book folio number, deposits, withdrawals, balance, and remarks (initials and date). Entries in ITM18872 and ITM844826 include the dates, Government Savings Bank stamps, the amount deposited and withdrawn, the balance and the initials of the Bank Officer.

These cash books record the Queensland National Bank Limited in account with the Inspector of Pacific Islanders, Maryborough. Details for each entry include the date, particulars of cash deposited (e.g. transfer and bond, return passages, wages), by whom (names of individuals, companies, Immigration Agent), amount, particulars of cheques drawn, in whose favour (names of individuals, Immigration Agent, ship owners), particulars of service (salaries and allowances, return passages, provisions etc) and amount.

Circulars to the Inspector of Pacific Islanders

These circulars were addressed to the Inspector of Pacific Islanders, Maryborough and sent by the Immigration Department, Pacific Island Labour Branch. ITM18849 includes directives sent to all Inspectors and others of concern only to the Maryborough Inspector. They relate to administrative matters such as records to be kept and returns to be forwarded to the Department, and the Commonwealth's assumption of responsibility for Pacific Island labourers after 1901. Matters relating directly to Islanders include the closure of the hospital, agreements, monies due to Islanders and Savings Bank deposits, return passages, deportations and exemptions, drunkenness of vessel crews, and firearms and ammunition on vessels. The final circular (250) advises of the date of closure of all Pacific Island labour offices on 31 July 1908.

Most were sent to the Immigration Agent, Brisbane (who was also the Inspector of Pacific Islanders), other government agencies such as the Government Labour Bureau, and individuals. Under the headings of the name of the employer, the estate (plantation) and district, details for entries of Islanders include the number of inward passenger list, name, gender, island, village, ship, date of arrival, date of agreement and expiration of agreement, rates of wages per annum and wages paid quarterly, by whom guaranteed, return passage when paid and by whom, Chief Officer reagreement folio reference, reference folio of last employer, re-agreement folio, subsequent information (employer name).

Book of Permits to Carry Pacific Islanders Coastwise

This book, <u>ITM18837</u>, contains stubs of permits signed by the Inspector of Pacific Islanders, Maryborough for carrying Islanders coastwise. Details entered on the permit include number, office (Maryborough) of the Pacific Island Immigration Department, date, and a statement that the master of the ship named had been granted permission to carry (number entered) of Islanders from the port of Maryborough to another named port. The permit then listed names, islands, and destination (e.g. Cairns, Townsville, Port Douglas, Brisbane, Rockhampton, Mackay, Geraldton/Innisfail, Bundaberg).

Logbooks of Vessels Helena and Lochiel

The log of Government Agent J.K. Craig written on the voyages of the Helena and the Lochiel, <u>ITM320853</u>. These voyages were undertaken to engage labour from the Pacific Islands and visited the New Hebrides and the Solomon Islands. Under Instruction 12 of the *Pacific Island Labourers Act 1880*, a daily log of occurrences on such voyages was compulsory. Details contained in the log include the ship's passage, weather conditions, movement of the agents and other boats, number and names of labourers and some personal details, as well as the ship's company, tonnage, owners of vessel, receipts for tonics, lotions, poultices and elixirs, directions for preserving food, destroying insects, and disinfecting clothes.

Legislation

The legislation is Queensland legislation unless otherwise noted. Acts as passed prior to 1900 are available through <u>Text Queensland</u> in the <u>Queensland Government Gazettes</u>, within the relevant year.

Polynesian Labourers Act 1868 – dealt with licenses, guarantees of returns, numbers of recruits, provisions, etc.

Pacific Islanders Protection Act 1872 – provided protection from kidnapping and other criminal offences. Amended in 1875.

Pacific Island Labourers Act 1880 (repealed the Act of 1868) – provided for regulation and control of the introduction and treatment of labourers from the Pacific Islands, limited the age of recruits, returns to islands, provision of medical treatments and rations, and dress allowance.

Pacific Island Labourers Act 1884 – confined labour to unskilled agricultural pursuits, crews to be paid wages, no firearms to be supplied, limited recruiting operations further.

Pacific Islanders' Employers' Compensation Act 1885 – introduced compensation for employers whose employees had returned to the islands, by order of the Government.

Pacific Island Labourers Act 1880 Amendment Act (1885) – prohibited further importation of labourers after 31 December 1890.

Pacific Island Labourers Act 1880 Amendment Act (1886) – amended the definition of Pacific Islanders.

Pacific Island Labourers (Extension) Act of 1892 – repeal of prohibition.

Immigration Restriction Act 1901 (Cwth) – described as an Act "to place certain restrictions on immigration and to provide for the removal from the Commonwealth of prohibited immigrants." A digital copy is available <u>here</u>.

Pacific Islands Labourers Act 1901-1906 (Cwth) – decreed there should be no further entry of Islanders after 31 March 1901. After that date deportation was to follow, with some exemptions. A digital copy is available here.

Sugar cultivation Act 1913 – prohibited employment of 'certain forms of labour in the production of sugar'.
