1 Provisions to facilitate the transfer of Functions to the Mackay Hospital and Health Service

1.1 Freehold Land (s 273A(2))

Transfer to the Service the State's (represented by Queensland Health) right, title and interest in each parcel/s of freehold land described as:

(a) Lot 2 on RP716157, title reference 20541198,

effective at the Effective Time.

1.2 <u>Conditions (s 273A(4))</u>

The transfer under clause 1.1 is subject to these conditions:

- (a) The transfer is subject to:
 - (i) all Existing Occupancy Rights; and
 - (ii) the right of the State (represented by Queensland Health) and those authorised by the State (represented by Queensland Health) to access the Transferred Property at any time after the Effective Time for the purpose of carrying out Major Capital Works (but except in the case of an emergency the State (represented by Queensland Health) must give the Service reasonable prior notice) and access for any other purposes under the Act.

The Service is bound by such rights with effect from the Effective Time and must comply with the terms and conditions of such rights. As a consequence of the transfer of the interests in the Transferred Property, transfer to the Service the State's (represented by Queensland Health) right, title and interest in the Fixed Assets (including the Building Services Plant and Equipment) in respect of the Transferred Property, effective at the Effective Time.

1.4 <u>Transfer of Ancillary Instruments and Performance Securities (s 273A(2))</u>

- (a) To the extent that they may lawfully be transferred, transfer to the Service the State's (represented by Queensland Health) right, title, interest and liabilities associated with:
 - (i) all Ancillary Instruments;
 - (ii) all Associated Agreements; and
 - (iii) all Performance Securities,

that relate to the Transferred Property, with effect from the Effective Time other than any such instruments, contracts, agreements which are Excluded Agreements.

- (b) With effect from the Effective Time, to the extent that any warranty or contractual or statutory right relating to the construction or operation of the improvements on the Transferred Property held by the State (represented by Queensland Health) is not transferred or is not capable of transfer, the State (represented by Queensland Health) holds such rights on behalf of and for the benefit of the Service and, if requested by the Service in writing, must enforce such rights at the cost of the Service.
- (c) The Service must not do or permit anything to occur which would void any warranty or contractual or statutory right relating to the construction or operation of the improvements on the Transferred Property held by the State (represented by Queensland Health) which is not transferred or is not capable of transfer.

1.5 Condition of Assets (s273A(4))

The transfer under **clause 1.1** and **clause 1.3** is subject to these conditions:

- (a) The Service accepts the Transferred Property on an as is basis at the Possession Date.
- (b) From the Possession Date, the Service must (at the cost of the Service) do all things reasonably necessary to carry out all repairs and maintenance (other than Major Capital Works, unless agreed with the State (represented by Queensland Health)) to the Transferred Property to keep the assets to a standard adequate for service.
- (c) After the Effective Time, if the Service carries out works to the Transferred Property which were compliant with all relevant building

codes at the Effective Time but as a result of the works carried out by the Service, upgrades are required to address current building codes, then the Service will be responsible for the cost of the upgrades.

- (2) are to be made or taken by or against the Service if the cause of action accrues on or after the Effective Time: and
