WESTERN DOWNS REGIONAL COUNCIL (MAKING OF LOCAL LAW) NOTICE (NO. 1) 2011

Title

1. This notice may be cited as *Western Downs Regional Council (Making of Local Law) Notice (No. 1) 2011*.

Commencement

NOTICE OF TEMPORARY EXEMPTION TO COMMISSION WATER RESTRICTIONS

(Water Act 2000 / Acts Interpretation Act 1954)

This Notice of Exemption ("Notice") is issued by the Queensland Water Commission ("the Commission") to provide for an exemption from parts of the Commission Water Restriction, Permanent Water Conservation Measures - Residential and Non-Residential which became effective on and from 1 December 2009 ("Commission Permanent Water Conservation Measures").

Residential premises are given a temporary exemption from schedule 1 of the Commission Permanent Water Conservation Measures as listed in the Exemption Schedule below for the period commencing 12.01am on Wednesday 16 November 2011 until 11.59pm on Sunday 27 November 2011 ("Exemption Period").

The temporary exemption will apply to residential premises within the local government areas of each Council in the SEQ region being:

Brisbane City Council;	Moreton Bay Regional Council;
Gold Coast City Council;	Redland City Council;
Ipswich City Council;	Scenic Rim Regional Council;

Schedule 2 of the Commission Permanent Water Conservation Measures will continue to apply during the Exemption Period.

This Notice by the Commission will not otherwise affect future operation of the Commission Permanent Water Conservation Measures beyond the exempted water uses as described in the Exemption Schedule attached to this Notice.

1. This notice may be cited as *Gladstone Regional Council (Making of Local Law) Notice (No. 1) 2011*.

Commencement

2. This notice commences on 1 December 2011.

Making of local laws

3. Gladstone Regional Council (the "Council") has, by resolution dated the 15th day of November 2011, made—
- each local law identified in schedule 1, column 1; and
 - each subordinate local law identified in schedule 1, column 2.

Existing local laws repealed

4. *Local Law (Repealing) Local Law (No. 1) 2011* repeals each local law identified in schedule 2.

Model local laws adopted

Title

1. This notice may be cited as the *Gympie Regional Council (Making of Local Laws) Notice (No. 1) 2011*.

Commencement

2. This notice commences on the date it is published in the Gazette.

Making of local laws

3. Pursuant to the provisions of the *Local Government Act 2009* the Gympie Regional Council adopted the following model local laws by resolution on November 9, 2011:
 - (a) *Model Local Law No. 1 (Administration) 2010*. The local law so adopted will be referred to as *Local Law No. 1 (Administration) 2011* of the Council's Local Laws. This local law contains anti-competitive provisions;
 - (b) *Model Local Law No. 2 (Animal Management) 2010*. The local law so adopted will be referred to as *Local Law No. 2 (Animal Management) 2011* of the Council's Local Laws. This local law contains anti-competitive provisions;
 - (c) *Model Local Law No. 3 (Community and Environmental Management) 2010*. The local law so adopted will be referred to as *Local Law No. 3 (Community and Environmental Management) 2011* of the Council's Local Laws. This local law contains anti-competitive provisions;
 - (d) *Model Local Law No. 4 (Local Government Controlled Areas, Facilities and Roads) 2010*. The local law so adopted will be referred to as *Local Law No. 4 (Local Government Controlled Areas, Facilities and Roads) 2011* of the Council's Local Laws;
 - (e) *Model Local Law No. 5 (Parking) 2010*. The local law so adopted will be referred to as *Local Law No. 5 (Parking) 2011* of the Council's Local Laws. This local law contains anti-competitive provisions; and
 - (f) *Model Local Law No. 6 (Bathing Reserves) 2010*. The local law so adopted will be referred to as *Local Law No. 6 (Bathing Reserves) 2011* of the Council's Local Laws. This local law contains anti-competitive provisions.
4. Pursuant to the provisions of the *Local Government Act 2009* the Gympie Regional Council made the following local law by resolution on November 9, 2011:
 - (a) *Repealing Local Law No. 1 (Miscellaneous Local Laws) 2011*. This local law repeals the local laws mentioned in clause 7 below.
5. Pursuant to the provisions of the *Local Government Act 2009* the Gympie Regional Council made the following subordinate local laws by resolution on November 9, 2011:
 - (a) *Subordinate Local Law No. 1 (Administration) 2011*, made under the authorising local law, *Local Law No. 1 (Administration) 2011*. This subordinate local law contains anti-competitive provisions;
 - (b) *Subordinate Local Law No. 2 (Animal Management) 2011*, made under the authorising local law, *Local Law No. 2 (Animal Management) 2011*. This subordinate local law contains anti-competitive provisions;
 - (c) *Subordinate Local Law No. 3 (Community and Environmental Management) 2011*, made under the authorising local law, *Local Law No. 3 (Community and Environmental Management) 2011*. This subordinate local law contains anti-competitive provisions;
 - (d) *Subordinate Local Law No. 4 (Local Government Controlled Areas, Facilities and Roads) 2011*, made under the authorising local law, *Local Law No. 4 (Local Government Controlled Areas, Facilities and Roads) 2011*.
 - (e) *Subordinate Local Law No. 5 (Parking) 2011*, made under the authorising local law, *Local Law No. 5 (Parking) 2011*. This subordinate local law contains anti-competitive provisions; and
 - (f) *Subordinate Local Law No. 6 (Bathing Reserves) 2011*, made under the proposed authorising local law, *Local Law No. 6 (Bathing Reserves) 2011*.

Purpose and effect of local laws

6. The purposes and general effect of the new model local laws is to provide for:
 - (a) a legal and procedural framework for the administration, implementation and enforcement of the local government's local laws, subordinate local laws and other regulatory powers, and for miscellaneous administrative matters;
 - (b) the management of animals by minimising the risk to community health, safety and amenity, reducing environmental harm or environmental nuisance, and supporting animal owners to keep their animals in a manner that is consistent with the expectations of the community;
 - (c) protection of community health, safety and amenity and the environmental values of the region within the local government's area by providing for the elimination or reduction of risks and threats to the environment and community health, safety and amenity resulting from:
 - inadequate protection against animal or plant pests; and
 - vegetation overgrowth; and
 - visual pollution resulting from accumulation of objects and materials; and
 - fires and fire hazards not regulated by State law; and
 - community safety hazards; and
 - noise that exceeds noise standards;
 - (d) protection of the health and safety of persons using local government controlled land, facilities, infrastructure and roads; regulation of the use of local government controlled land, facilities, infrastructure and roads to prevent property damage or a loss of amenity or a nuisance; and preservation of features of the natural and built environment and other aspects of the amenity of local government controlled land, facilities, infrastructure and roads;
 - (e) exercise of local government powers under the regulated parking provisions in chapter 5, part 6 of the *Transport Operations (Road Use Management) Act 1995*, including:
 - the establishment of traffic areas and off-street regulated parking areas;
 - lawfully parking contrary to an indication on an official traffic sign with a parking permit or in a loading zone with a commercial vehicle identification label;
 - the prescribing of infringement notice penalties for minor traffic offences; and
 - (f) enhancement of public safety and convenience of bathing reserves placed under the local government's control through orderly management and regulation of activities within these reserves.

8. The purpose and effect of the new subordinate local laws is to supplement the authorising local laws by:

- (a) in relation to administration — providing for:
 - various matters regarding the granting of approvals for prescribed activities; and
 - further specification of the definitions relevant to prescribed activities;
- (b) in relation to the keeping and control of animals — providing for:
 - the circumstances in which the keeping of animals is prohibited or requires approval; and
 - requirements for keeping animals, including minimum standards for keeping animals, identification for animals, requirements for keeping declared dangerous animals and conservation requirements for keeping animals in relevant areas; and
 - the control of animals in public places; and
 - matters regarding the impounding of animals and the disposal of impounded animals;
 - the conditions to be complied with by persons who offer animals, or a particular species of animals, for sale; and
 - the declaration of a species of animal as a declared dangerous animal and the criteria for declaration of a specific animal as a declared dangerous animal;

-
- (c) in relation to the protection of the environment and public health, safety and amenity — providing for:
- declaration of local pests; and
 - prohibition of lighting or maintaining certain fires; and
 - declaration of fire hazards; and
 - declaration of community safety hazards; and
 - prescribed requirements for owners of land containing community safety hazards; and
 - declaration of noise standards;
- (d) in relation to local government controlled land, facilities, infrastructure and roads — providing for:
- the regulation of access to local government controlled areas; and
 - the prohibition or restriction of particular activities in local government controlled areas or roads;
- (e) in relation to parking — providing for:
- the establishment of traffic areas and off-street regulated parking areas; and
 - the persons who may be issued with a permit to park a vehicle contrary to an indication on an official traffic sign; and
 - the vehicles that can be issued with commercial vehicle identification labels; and
 - the infringement notice penalty amounts for minor traffic offences;
- (f) in relation to bathing reserves — providing for:
- the regulation of the use of aquatic equipment; and
 - the appointment and powers of authorised persons to manage and enforce the regulation of conduct.

Inspection

9. 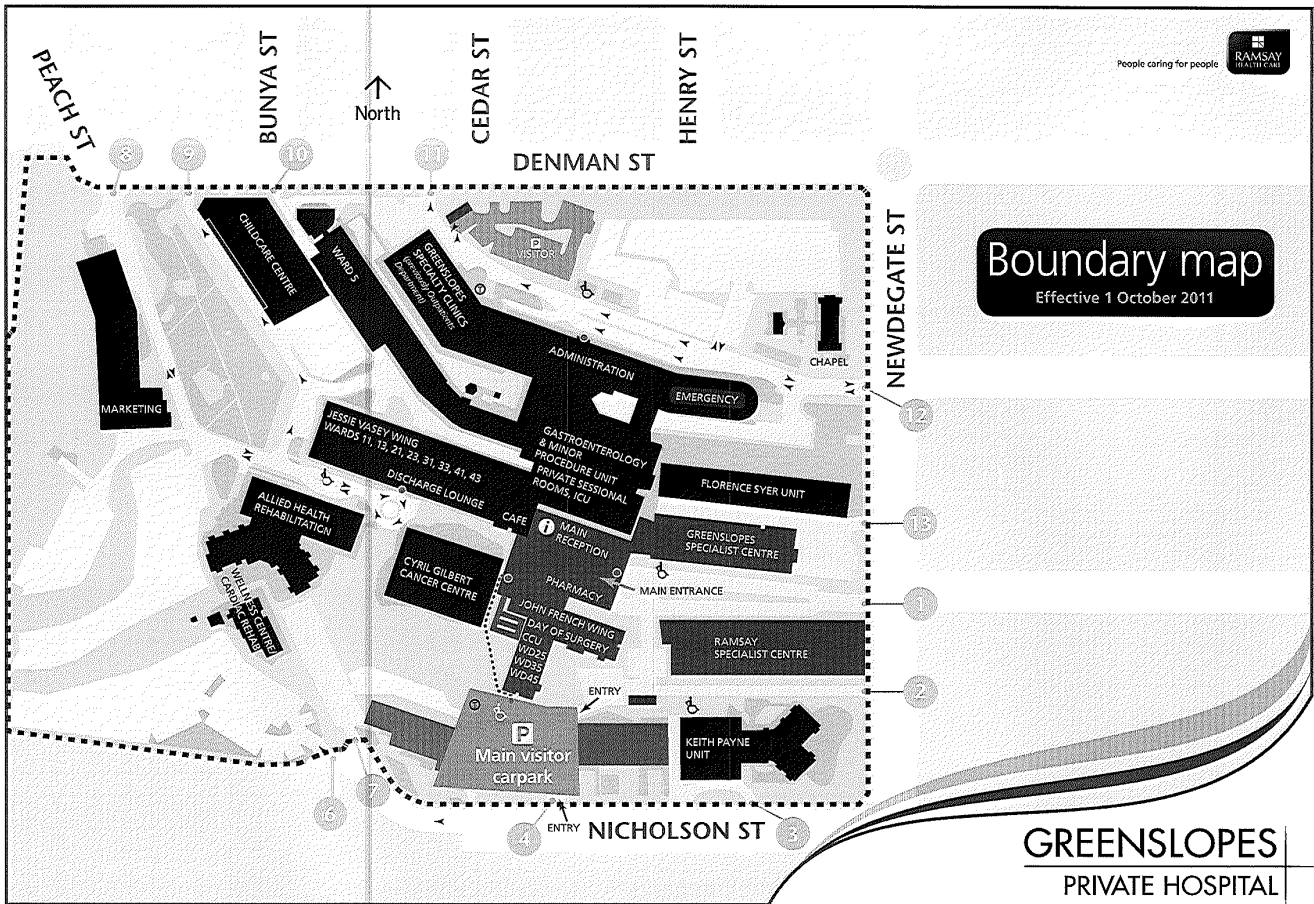

- (c) remove any obstruction or Structure placed or existing on the Easement Land irrespective of the reason or means by which the obstruction or Structure came to exist on the Easement Land (except a Structure erected with the prior written consent of the Grantee, as provided for in clause 4.1(a));

(d) inspect or survey the Easement Land, or any Structure on it, from time to time; and

(e) if reasonably necessary to give effect to the Grantee's rights under the Easement, pull down or break open any fencing on the Easement Land (but only after, except in the case of an emergency, giving reasonable prior notice to the Landowner) and provided that the fence is reinstated to the extent reasonably required by the Grantor.

2.2 The Landowner acknowledges that the Grantee may elect to carry out the gardening on that part of the Easement Land which borders the Benefited land.

2.3 In exercising its rights and powers under the Easement, the Grantee must:

- (a) ensure that any work is done properly;
- (b) cause as little inconvenience as is reasonably practicable in the circumstances to the Landowner;
- (c) comply with all applicable laws regarding occupational, health and safety; and
- (d) except in the case of an emergency or where it is not otherwise practicable, give the Landowner reasonable prior notice.

2.4 If the Landowner breaches the Easement, the Grantee may do anything that is reasonably necessary to correct the breach (such as removing an obstruction or Structure erected on the Easement Land or constructing, installing, repairing, maintaining, adding to, altering and replacing any roads, driveways, fences or gates in or on the Easement Land) without the Grantee incurring any liability to the Landowner. The Grantee is to be indemnified by the Landowner for the reasonable costs incurred by the Grantee in rectifying the Landowner's unremedied breach of the Easement.

3 COSTS

3.1 The Landowner is responsible for carrying out and paying all costs associated with the ongoing maintenance of the Easement Land and electricity charges for lighting the Easement Land.

3.2 The Grantee is not responsible for any costs associated with the Easement Land and the future development of the Easement Land (including any widening of the Access Road).

4 OBLIGATIONS OF LANDOWNER

4.1 The Landowner must:

- (a) not change (other than removing any obstruction or Structure erected on the Easement Land in breach of the Easement) or erect or permit to be erected any obstruction or Structure whether permanent or temporary (except a road not inconsistent with any road constructed by the Grantee) on the Easement Land without the prior written consent of the Grantee;
- (b) not alter the ground level of the Easement Land or change its topography or do anything to cause inundation of the Easement Land by water without the prior written consent of the Grantee;
- (c) not plant trees on the Easement Land without the prior written consent of the Grantee;
- (d) not crop, dig or plough the Easement Land or cause the lighting of fires on the Easement Land, or allow fire to exist on the Easement Land, without the prior written consent of the Grantee;
- (e) not cause a nuisance that adversely affects the exercise by the Grantee of its rights and powers under the Easement from time to time and if any nuisance is caused, then the Landowner must promptly abate such nuisance;
- (f) use the Landowner's best endeavours to prevent anyone else doing any of the things that the Landowner is required not to do under the Easement and not allow or authorise anyone else to do any of those things;
- (g) not interfere with or obstruct the Grantee in the exercise of its rights and powers under the Easement; and

- (h) not grant any rights to any person in relation to the Easement Land to the extent the granting of those other rights could or will conflict or interfere with the exercise by the Grantee of any of the Grantee's rights and powers under the Easement,

4.2 Nothing in this Easement prevents the Landowner constructing fences on the Lateral Boundaries or parallel to the Lateral Boundaries, provided:

- (a) that the fences allow for vehicular and pedestrian access to and egress from the Benefited Land as intended by this Easement; and
- (b) the Landowner must not construct a fence on the boundary between the northern end of the Benefited Land and Easement Land without the prior consent of the Grantee (such consent not to be unreasonably withheld).

4.3 The Landowner is responsible for the negligent acts and omissions of anyone lawfully claiming through the Landowner (like tenants, licensees and mortgagees).

5 OTHER MATTERS

5.1 Mining or petroleum tenement

The Landowner is to use the Landowner's best endeavours to give the Grantee a copy of any notification received by the Landowner in respect of any application for a mining or petroleum tenement under the *Mineral Resources Act 1989*, the *Petroleum Act 1923*, the *Petroleum and Gas (Production and Safety) Act 2004* or any similar or replacement legislation, in respect of land which includes the Easement Land, within 7 days after the Landowner receives such notification.

5.2 Further assurances

- (a) The Landowner will execute every deed, instrument, assurance or other document and do all such things as may be necessary to secure the rights of the Grantee conferred by the Easement as the Grantee may reasonably require, including (without limitation) obtaining the consent of any person necessary and producing the title documents relating to the Easement Land and executing all documents necessary to give effect to any proposed assignment or transfer or other dealing by the Grantee in respect of the Benefited Land.
- (b) If required under a law to allow the Grantee to lodge a development application (or similar application) in respect of the Benefited Land, the Landowner agrees to sign a consent to such application (as the owner of the Easement Land).
- (c) The signing of a consent under clause 4.3(b) does not fetter any rights of the Landowner to object to such application under the normal objection rights in respect of development applications (or similar applications).

6 NOTICE

6.1 General

Any notice, demand, certification, process or other communication given in relation to the Easement must be in writing in English and may be signed by an authorised officer or agent of the party giving the notice.

7 GRANTEE'S CONSENT

The Grantee may conditionally or unconditionally give or withhold any consent to be given under the Easement and is not obliged to give reasons for doing so.

8 SEVERABILITY

- (a) Subject to clause 8(b), if a provision of the Easement is illegal or unenforceable in any relevant jurisdiction, it may be severed for the purposes of that jurisdiction without affecting the enforceability of the other provisions of the Easement.
- (b) Clause 8(a) does not apply if severing the provision materially alters the scope and nature of the Easement or would be contrary to public policy.

9 INDEMNITY FOR LANDOWNER

The Grantee indemnifies the Landowner against all actions, suits, proceedings, demands, claims, losses, damages, costs and expenses, excluding any indirect or consequential loss ("Claims") arising from:

- (a) any breach by the Grantee of the terms of the Easement; and
- (b) any act or omission of the Grantee in the exercise of its rights and powers under the Easement;

except to the extent that any Claims are:

- (c) caused; or
- (d) contributed to (but only to the extent of that contribution), by the act or omission of the Landowner or its employees, officers, agents, contractors, subcontractors, tenants or licensees.

10 BENEFIT AND BURDEN

10.1 The benefit of this easement and the covenants contained in it shall pass with and bind the successors in title of the Benefited Land and the Easement Land respectively.

10.2 On ceasing to be the registered owner of the Easement Land and the Benefited Land respectively, the relevant party ceasing to be the registered owner of the Easement Land or the Benefited Land shall be released from all obligations under this Easement and shall have no further liability for any event or occurrence under this Easement with the exception of any antecedent breaches.

11 GOVERNING LAW AND JURISDICTION

11.1 The law of Queensland governs this Easement.

11.2 The parties submit to the non-exclusive jurisdiction of the Courts of Queensland and the Federal Court of Australia.
