A PROCLAMATION

By His Excellency the Honourable Paul de Jersey AC, Governor in and over the State of Queensland and its Dependencies, in the Commonwealth of Australia.

WHEREAS Her Majesty has been graciously pleased to appoint me, the Honourable Paul de Jersey AC, to be Governor in and over Her Majesty's said State of Queensland and its Dependencies, in the Commonwealth of Australia: Now therefore I, the Governor aforesaid, do hereby notify, proclaim and make known that I have this day taken the prescribed Oath before the Honourable Timothy Francis Carmody, the Chief Justice of Queensland, and that I have assumed the office of Governor of the said State accordingly.

Given under my Hand and Seal, at Parliament House, Brisbane, this twenty-ninth day of July, in the year of our Lord two thousand and fourteen and in the sixty-third year of Her Majesty's reign.

I. We do, by this Our Commission under Our Sign Manual and the Public Seal of the State of Queensland, appoint you, the said Paul de Jersey AC, to be, during Our pleasure, Our Governor in and over Our State of Queensland and its Dependencies, in the Commonwealth of Australia, with all the powers, rights, privileges and advantages to the said Office belonging or appertaining;

II. And We do hereby authorise, empower and command you to exercise and perform all and singular the powers and functions appertaining to that office;

And We do hereby appoint that so soon as you shall have taken the prescribed oaths and have entered upon the duties of your Office, this Our present Commission shall supersede the Commission under Our Sign Manual and Signet, bearing date the first day of July 2008, appointing Our Trusty and Well-beloved Ms Penelope Wensley AC;

IV. And We do hereby command all and singular Our Officers, Ministers, and loving subjects in Our said State and its Dependencies, and all others whom it may concern, to take due notice hereof and to give their ready obedience accordingly.
