

# Application for a horse and cattle brand and/or earmark

Brands Act 1915 and Brands Regulation 2012

#### Purpose of this form

This is an application to become a registered owner of a horse and cattle brand or earmark. Failure to provide information required in this form may result in your application not being processed and your application fee forfeited. Fees will not be refunded if you choose to discontinue with your application when only one choice of brand/earmark is nominated.

# Information to assist in applying for a horse and cattle brand and/or earmark can be found at www.business.qld.gov.au/branding-livestock

The issue of a particular brand or earmark depends upon it not being similar to or easily convertible into any other in the same locality. Owners are responsible for obtaining their own branding and earmarking instruments once a Certificate has been issued by the Registrar of Brands (Registrar). The instruments must replicate the images in the Registration Certificate. The Registrar must be notified of any alteration to the registration details of a brand or earmark.

A brand return must be submitted annually. Failure to lodge the return at any time during any three consecutive years will render the brand and/or earmark liable for cancellation. The Department of Agriculture and Fisheries (DAF) must be notified without delay, in writing, of any change of address.

#### **Privacy Statement**

DAF collects the information on this form for the primary purpose of processing and considering your application for registration of a brand and/or earmark under the *Brands Act 1915* (Act). DAF also collects the information on this form for the purpose of identifying the owner of brands and/or earmarks in order to facilitate the transfer of ownership of brands and/or earmarks under the Act.

The information you provide, including your personal information, will be used to assist DAF in its regulatory function under the Act and will be recorded and maintained in the Animal Identification System (AIS) database which records brands and earmark identification. The AIS database is a secure database accessible by authorised departmental personnel only. In order to assist in the identification and return of stock, your personal information, such as your name, property address and postal address will be recorded on the Brands Register which is accessible by the public. Your telephone number and email address will not be recorded on the Brands Register. Subject to this privacy statement, your personal information will not be disclosed to any other third party without your consent, unless the disclosure is authorised or required by law.

Any personal information you provide will be treated in accordance with DAF's Privacy Statement. - Please note that if your search result indicates that a brand is available it is still **not** an automatic allocation.
- A brand preference will not be issued if it does not conform to the Act or if it is similar to, or easily convertible into, any other registered horse and cattle brand on the same property or in the same locality (i.e. used on an adjoining property).
- A decision as to whether a three-piece horse and cattle brand is issued is a decision for the Registrar at the time of assessing
  your application.
- A branding instrument is **not** to be manufactured until a Certificate of Registration is received and the branding instrument is to replicate the image on the certificate.

- Select search
- If the Symbol brand you searched displays, it is **not** available to register
- If the Symbol brand search does <u>not</u> display, this option may be nominated as one of your 6 preferred options.

You must nominate six (6) horse and cattle symbol brand choices, in order of preference.

- Please note that if your search result indicates the symbol brand is available it is still **not** an automatic allocation.
- A symbol brand will not be issued if it does not conform to the Act or if it is similar to, or easily convertible into, any other registered brand on the same property or in the same locality (i.e. used on an adjoining property).
- A decision as to whether a symbol brand is issued is decided by the Registrar at the time of assessing your application.
- A branding instrument is not to be manufactured until a Certificate of Registration is received and the branding instrument is

- If the Earmark you searched displays, it is **not** available to register
- If the Earmark search does <u>not</u> display, this option may be nominated as one of your 3 preferred options.


#### You must nominate three (3) cattle earmark choices, in order of preference.

- Please note that if your search result indicates the earmark is available it is still **not** an automatic allocation.
- Cattle earmarks may only be used in their registered district.
- A cattle earmark preference will not be issued if already registered in the same district, if it does not conform to the
  Act or if it is similar to, or easily convertible into, any other registered earmark on the same property or in the same
  locality (i.e. used on an adjoining property).
- Whether an earmark is issued is a decision for the Registrar at the time of assessing your application.
- Earmarking pliers are not to be manufactured until a Certificate of Registration is received.

A cattle earmark may only be used in the district for which it is registered and on an animal which already bears the brand with which the earmark is registered.

A cattle earmark can only be registered in the same name/s as the horse and cattle three-piece brand.

Applications will be processed on information provided by the applicant. If you do not complete this section, the Registrar will issue a certificate on the basis that you do not have neighbouring properties. If an objection is lodged by a neighbour whereby the brand/earmark issued is similar to, or easily convertible to their brand, your brand/earmark will be cancelled. You will then be required to submit a new application and pay the relevant fee.

Complete the particulars of adjoining neighbours or other persons whose stock, are likely to be in contact with the applicant's stock.

- The issue of a particular brand or earmark depends upon it <u>not</u> being similar to, or easily convertible into, any other used on the same property or in the same locality (adjoining neighbours). **This information is required before the application can be processed.**
- **If you do not know your neighbours' brands**, you must provide full name and address of all neighbours (bordering property owners) including property or station name.
