## AIRPORTLINKM7 NOTIFICATION OF TOLLS, ADMINISTRATION CHARGES AND USER CHARGES

- <sup>3</sup> A vehicle registration database fee is also payable, which is the fee charged by DTMR from time to time for a single request for vehicle registration information. The current fee charged is \$0.45.
- <sup>4</sup> A Standard Casual Use Product (Trip and Day Pass) Purchase Fee of \$3.05 is applicable to transactions made by phone through the contact centre. This fee has been applied to the Maximum Toll Payable but is excluded from the actual charges payable column that will apply to purchases via the web.
