Notice of the establishment of a lesser restrictions area within the electric ant biosecurity zone (No. 2) 2025

(Section 74A(1) of the *Biosecurity Regulation 2016* and section 129(1)(c) of the *Biosecurity Act 2014*)

Background

1. On 30 September 2024, the *Biosecurity Regulation 2016* (the Regulation) established the part of the State of Queensland identified as the electric ant biosecurity zone (the *electric ant biosecurity zone*) on the map called 'Electric Ant Biosecurity Zone Map – EA03' dated 30 September 2024 as a biosecurity zone for electric ants (*Wasmannia auropunctata*).

Power to establish lesser restrictions area

- 2. Under section 74A(1) of the Regulation, the Chief Executive may, under section 129(1)(c)(i) of the *Biosecurity Act 2014* (the Act), establish particular areas (each a *lesser restrictions area*) within the electric ant biosecurity zone.
- 3. In accordance with section 74A(1) of the Regulation and section 129(1)(c)(i) of the Act, I provide that on 24 June 2025, the part of the electric ant biosecurity zone not identified in the following maps as an electric ant restricted zone is established as a lesser restrictions area within the electric ant biosecurity zone:
