# AMENDING TAKING OF LAND NOTICE (No. 1) 2022

# Short title

1. This notice may be cited as the Amending Taking of Land Notice (No. 1) 2022.

# Amendment of Land taken [s.11(1) of the Acquisition of Land Act 1967]

The MID includes requirements in relation to the location and scale of the development, stormwater management, vegetation, mitigation of koala impacts, landscaping, privacy measures, fencing, design/built form, school transport management, active transport, car parking, external works, construction management, information signage, lighting, refuse and plant screening, servicing, geotechnical conditions and acid sulfate soils.
