# Owner-builder cost summary and lodgement guide

### Guide to completing the owner-builder cost summary annexure

Keep this guide for future reference. It contains important information about owner-builders and the Queensland first home owner grant. The general information in this guide does not cover every aspect of the First Home Owner *Grant and Other Home Owner Grants Act 2000* (the Act).

Meanings of terms used in this document are on pages 1-2.

### When you need to complete the owner-builder cost summary annexure

If you are building a new home as an owner-builder, on or after 1 July 2000, and are applying for the Queensland first home owner grant, you must complete the owner-builder cost summary annexure showing the total costs incurred for the construction of your home. The costs included in the annexure must reflect the consideration for all work performed from commencement to completion of the eligible transaction.

### Where to lodge your documents

Applications and supporting documents must be lodged within 12 months of completion of the eligible transaction.

There are 3 ways you can lodge your completed application and supporting documents.

- 1. Have your financial institution (approved agent) that is providing your finance lodge your application for you. A list of approved agents can be found at **qro.qld.gov.au**. If you need the grant for settlement or want to receive it as soon as possible, you need to lodge your application with an approved agent.
- 2. Lodge online, using Queensland Revenue Office's (QRO) FHOG Online Application Portal at www.firsthome.gov.au/apply/qld.
- 3. Post or email the completed application form and supporting documents to QRO.

Note: Applications cannot be lodged with QRO until completion of the eligible transaction.

### How to complete this form

All applicants must complete this form.

- If you are completing this form electronically, save this form to your device to add a digital signature.
- If you have printed this form to complete, use blue or black ink only. If you have made any mistakes, do not use correction fluid or white out; simply cross out the mistake. All applicants must initial every correction.
- If you are applying via an approved agent, take this completed form and application to the agent. They will confirm your eligibility and manage your application.
- This form has four sections—applicant details, property details, building cost summary and a declaration.
- When completing this form, print or type all responses in the boxed spaces. If there is insufficient space, attach additional forms or pages.

# **Section 3 Building cost summary**

You need to provide the total costs for the construction of your home from the date the laying of foundations started to the date the home was completed and ready for occupation. Using the table below, provide the details for all stages of building works, including a short description of the work, the cost incurred and the receipt or invoice number showing evidence of payment. If there is insufficient space, attach additional forms or pages.

You must provide receipts equal to or greater than the grant amount payable. The Commissioner may request you to produce all receipts evidencing the total costs incurred.

### Stages of work

**Site** The cost of excavation and site preparation work, including site surveys or testing,

clearing, levelling, retaining walls, first stage plumbing and electrical, labour to perform

the work and relevant certification costs

**Foundation** The cost of preparation and laying of foundations, including the materials, vapor barrier,

structural reinforcements, footings, piers, columns, foundation walls, supporting beams,

slab, labour to perform the work and relevant certification costs

**Structure** The cost of preparing and installing structural components, including the materials,

frame, walls, roof trusses, windows, door frames, external doors, guttering, brickwork, stairs, handrails, balustrades, waterproofing, plumbing, electrical, labour to perform the

work and relevant certification costs

**Fit-out** The cost of preparing and installing internal fit-out or cosmetic components, including

internal doors, kitchen, bathroom, shelving, cabinetry, skirting boards, cornice,

benchtops, appliances, fixtures, flooring (including tiling), painting, labour to perform the

work and relevant certification costs

**External** The cost of external works contained within a building contract, including landscaping,

fencing, a swimming pool and any other detached structures, such as a shed, garage or

detached granny flat, labour to perform the work and relevant certification costs

Other Air conditioning or any other building work not specified above

- 2. I declare construction of my new home commenced on or after 1 July 2000.
- 3. I understand that the purpose of this form is to declare to the Commissioner the consideration for building a new home as an owner-builder and that the information in this form will be used to consider eligibility for a grant under the Act.
- 4. I declare that I will notify the Commissioner and repay the grant within 28 days if, upon completion of the eligible transaction, the value of my home is greater than or equal to \$750,000.
- 5. I understand that if I do not comply with the obligations of the grant, I may not be entitled to receive or retain the grant.
- 6. I have read and understood the 'Guide to completing the owner-builder cost summary annexure' and will keep it for future reference.
- 7. I authorise QRO to access and exchange information about me to verify my eligibility for the grant with the approved agent (where applicable); other state, territory and Australian Government agencies; and commercial organisations as permitted by law.
- 8. I confirm that I am authorised to provide the personal details presented and I consent to my information being checked with the document issuer or official record holder via third party systems for the purpose of confirming my identity.
- 9. I authorise QRO to disclose confidential information in connection with the administration or enforcement of the First Home Owner Grant and Other Home Owners Grant Act or a corresponding law.
- 10. I acknowledge that to make a false or misleading statement on, or in connection with, the supporting documentation relating to my application for the grant may result in penalties and/or prosecution.
