Research Guide to nurse records
at Queensland State Archives

Queensland State Archives (QSA) is the official repository for Queensland Government records selected for permanent retention because of their continuing value. The archived public records are from state government departments, state courts, local government authorities and statutory authorities. The records are in our facility at [Runcorn, Brisbane](#), and open records are available for viewing in the Reading Room, free-of-charge.

This guide provides an administrative history of nursing agencies in Queensland and identifies the major series of records held by Queensland State Archives in relation to nurses and the nursing profession.

Initially, the Royal Brisbane and Women's Hospital was responsible for nurses' education and training. Under the *Health Act Amendment Act 1911* a Nurses' Registration Board was established, and the first members were appointed on 22 Feb 1912.

With the need to standardise the education, training and registration of nurses, the Nurses and Masseurs Registration Board was established on 1 Jan 1929. This Board was disbanded when the Physiotherapists Board of Queensland and the Nurses Board were set up on 27 Jul 1965.

During the period 1935 to 1963 the Department of Health and Home Affairs oversaw nurses' registration and controlled the Nurses and Masseurs Registration Board. The Department also oversaw many areas where nursing services were required such as baby clinics, maternal and child welfare homes, dental and medical clinics, hospitals, homes for the insane, epileptics, inebriates, and repatriates.

On 23 Dec 1976 the decision was made to separate the function of registration from education and training. This was done by establishing the Board of Nursing Studies, and the Nurses Registration Board of Queensland was re-established as a result. Subsequently, the Queensland Nursing Council was established under the *Nursing Act 1992* replacing the Board of Nursing Studies and the Nurses Registration Board of Queensland.

From 1 July 2010 the Queensland Nursing Council was abolished and a new national agency, the Australian Health Practitioner Registration Agency, responsible for administration of registration of health professionals was introduced under the *Health Practitioner Regulation (Administrative Arrangements) National Law Act 2008*, the *Health Practitioner Regulation National Law Act 2009* and the *Health Legislation (Health Practitioner Regulation National Law) Amendment Act 2010*. The national agency took over the administrative functions of the nursing council while the Nurses and Midwifery Board took over the registration and accreditation of nurses and midwives. The function of registration boards was to administer enabling legislation, determine professional standards, maintain the register of practitioners, and regulate and control practitioners. Responsibilities included maintaining a register of nurses, determining the scope of nursing practice and standards, accrediting nursing courses and monitoring training standards.

The main finding aid for records held at QSA is the [Queensland State Archives' online catalogue](#) (known as ArchivesSearch).

The following citation abbreviations are used throughout our catalogue:

- ITM QSA Item (describes the item)
- PR Physical Representation (generally the original or microfilm copy)
- DR Digital Representation (for a digital image)
- S Series ID (for a series of records)
- A Agency ID (for the creating or responsible agency).

Correspondence between the Auditor-General, auditors, audit inspectors and local authorities is also included as well as some meeting and business papers. The reports were written between 1957 and 1983, although some of files contain relevant information dated prior to 1957.

Health and Home Affairs Department

General Correspondence

Circa 1/1/1936 - Circa 31/12/1974

This is the main series of correspondence (inwards and outwards) of the Health and Home Affairs Department and it covers the whole range of the functions and responsibilities of the Department which included health and, to 1963, various other internal matters which were the responsibility of the Home Affairs Office.

An annual single number system of file registration is used for in-letters. A carbon copy of each out-letter is filed with (and given the same number as) the in-letter to which it is a reply. As a top-numbering system is used, to find a particular letter, it is necessary to trace the sequence of numbers through the registers until the final number is reached.

There are over 230 files in this series which relate specially to nurses and nursing. Using ArchivesSearch with the keyword "Nurse"; select *Items* and filter by [S6679](#) to find the files. Topics mainly cover the 1950s and include mental hygiene nurses, maternal and child welfare nurses, chief office nurses, health nurses, hospital and institution nurses, school health nurses and staff nurses.

Press Cuttings Files

Circa 1/10/1957 - Circa 30/9/1971

The press cuttings are mainly from the *Melbourne Herald and Sun*; *Adelaide Advertiser*, *Sydney Herald*, *Telegraph and Sun*; *Queensland Telegraph*, *Courier Mail*, *Sunday Mail*, *North Queensland Register* and *Sunday Truth*. The cuttings contain various topics relating to hospitals, health and medical schemes. Also included are details on nurses, doctors, pharmacy, mental hygiene, maternal and child welfare.

Special Batches

This series consists of batches of correspondence and papers which were removed from (or not included in) the general correspondence of the Colonial Secretary's/Home Secretary's Office, and the subsequent Health and Home Affairs Department and Health Department. The letters removed either for administrative convenience or because the subject was particularly important were entered in the Registers of Letters Received with a note often specifying 'Away Batch'.

With the creation of the Health and Home Affairs Department in 1935 and the subsequent Health Department in 1963, the majority of batches became health-related. Using [ArchivesSearch](#) with the keyword "Nurse"; select *Items* and filter by [S8400](#) to find the files. Topics include nurses and masseurs, registration boards, migrant nurses and health acts.

Also included are a list of questions for witnesses that were called by the Commission, pharmacy journals, and a hand-written notebook concerning the commission kept by Dr C A Thelander of the Brisbane clinic on Wickham Terrace, Brisbane.

These books record monthly salaries and wages paid to the staff of the Brisbane Hospital. Details for each entry in the volumes 1870-1888 include the name, and sometimes the position of the staff member, the amount paid, and the signature acknowledging receipt. The pages of the volume 1889-1896 are headed 'pay sheet for month of' and include the name, grade, date from and to, and the amount.

Religious and Charitable Files

Circa 1/1/1861 - Circa 30/6/2002

The *Religious Educational and Charitable Institutions Act, 1861* enabled the Executive Council to issue Letters Patent to religious, educational and charitable groups. Organisations registered under the Act were able to manage estates, properties and effects; receive and purchase property; borrow and lend money; sue and be sued; invest money; purchase and trade shares; inherit money or goods from an estate when the deed of grant was made at least one month prior to the person's death in the presence of three credible witnesses. Organisations had to file proof of succession with the Supreme Court. Files may include correspondence, affidavits as to the identity of those elected to management positions and an organization's constitution.
