Research Guide to Firms records at Queensland State Archives

Queensland State Archives (QSA) is the official repository for Queensland Government records selected for permanent retention because of their continuing value. The archived public records are from state government departments, state courts, local government authorities and statutory authorities. The records are in our facility at <a href="Runcorn">Runcorn</a>, <a href="Brisbane">Brisbane</a>, and open records are available for viewing in the Reading Room, free-of-charge.

The *Registration of Firms Act 1902* provided for the registration of firms in Queensland. According to the Act, a firm is not a company and it is defined as any person individually or any two or more persons in association or partnership carrying on any business in Queensland under any firm name. A firm is an unincorporated body of persons associated together for the purpose of carrying on a business. In common usage, the term company is sometimes used as part of the name of a firm. However, in legal usage, the term company is confined to incorporated associations operating in commerce or industry.

Under the Act, a principal registrar and the district registrars were appointed to manage the registration of firms in Queensland. In the absence of a district registrar this role was also carried out by the Clerk of Petty Sessions in Petty Session Districts.

QSA holds records relating to firms from 1902 onwards. These records have been created by various agencies including the Principal Registrar of Firms, Registrar of Firms for various districts, Courts of Petty Sessions District registries and the Treasury Department.

The main finding aid for records held at QSA is the <u>Queensland State Archives' online catalogue</u> (known as ArchivesSearch).
