ADOPTION OF AMENDMENT NO.22 TO THE TOOWOOMBA REGIONAL PLANNING SCHEME (MINOR AMENDMENT)

Notice is hereby given that on 20 August 2019 the Toowoomba Regional Council adopted the Toowoomba Regional Planning Scheme – Amendment No. 22 (Minor Amendment).

The amendment commences on 23 August 2019.

A change has been made to the local government area boundary between the Toowoomba Region and Southern Downs regional councils. As a result, there is a small portion of land on the region's south-eastern area that is now included within the Toowoomba Region. This amendment to the Toowoomba Regional Planning Scheme's zone and overlay mapping has been made to ensure this land is included in the planning scheme.
