  - replacement of references to Urban Stormwater Flow Path Areas with Urban Catchment Flow Paths; and
  - updates to the AFRL, 1 in 20 Development Line and Urban Catchment Flow Paths to reflect changes resulting from actual approved earthworks and development.
- Amendments to the Ipswich Planning Scheme relating to the management of development in flood hazard areas, including amendment to:
  - Part 11, Section 11.4.7: Flooding and Urban Stormwater Flow Path Areas;
  - Part 11, Table 11.4.3: Assessment Categories and Relevant Assessment Criteria for Development Constraints Overlays—Making a Material Change of Use;
  - Part 11, Table 11.4.4: Assessment Categories and Relevant Assessment Criteria for Development Constraints Overlays—Other Development; and
  - Part 12, Section 12.15.4: Earthworks Code (including Lot Filling), Clause (8) Flooding and Drainage.
- Consequential Planning Scheme amendments, including the correction of references and amendments to definitions.

  - Table 5.5:19 – Rural zone
  - Table 5.5:14 – Community Facilities zone
  - Table 5.6:1 – Reconfiguring a Lot
  - Table 5.9:3 – Charlton Wellcamp Enterprise Area Local Plan: material change of use where in the Medium Impact Industry Zone (Transport and Warehousing Precinct); and
- (ii) Applies the following provisions of the Toowoomba Regional Planning Scheme to the extent that development is for material change of use:
  - Table 5.5:9 – Medium Impact Industry zone

Conditions and clauses contained within the section 31 agreement between Santos TOGA Pty Ltd, PAPL (Upstream) Pty Limited, Santos TPY CSG Corp., Santos TPY Corp., Santos Queensland Corp., Total E&P Australia, KGLNG E&P Pty Ltd, Total E&P Australia II and Bronco Energy Pty Limited Karingbal People, Karingbal People #2, Bidjara People, Bidjara #7 and the State of Queensland signed by the Minister for Natural Resources and Mines on 17 April 2014.

**(b) Landholder Notification of Nominated Incidents**

- (i) The holder must notify each relevant owner and occupier of land of a nominated incident.
- (ii) The notification required must be given in the way and within the time prescribed in a relevant manual.
- (iii) The terms "nominated incident" and a "relevant owner and occupier" have the meaning prescribed in a relevant manual.
- (iv) A relevant manual is a manual (however called), as varied from time to time, about petroleum authority administration practice kept by the chief executive under section 858A of the Act.
