**NOTICE OF THE MAKING OF TEMPORARY LOCAL  
PLANNING INSTRUMENT No. 1 of 2025  
(COLMSLIE ROAD INDUSTRIAL PRECINCT) (TLPI No. 1/2025)  
BRISBANE CITY COUNCIL LOCAL GOVERNMENT AREA**

I, the Honourable Jarrod Bleijie MP, Deputy Premier, Minister for State Development, Infrastructure and Planning and Minister for Industrial Relations, notify that I have made TLPI No. 1/2025 in accordance with section 27(3) of the *Planning Act 2016* (the Planning Act) and the Minister's Guidelines and Rules. TLPI No. 1/2025 will have effect on 13 June 2025 and will have effect for a period of two years unless repealed sooner.

**Purpose and General Effect**

TLPI No. 1/2025 is a Temporary Local Planning Instrument (TLPI) under section 23 of the Planning Act. Under section 23(3) of the Planning Act, a TLPI may suspend or otherwise affect the operation of another local planning instrument but does not amend or repeal the instrument.

The purpose of TLPI No. 1/2025 is to regulate development applications for non-industrial activities on land within the TLPI boundary of the Colmslie area in the Brisbane region to ensure this regionally significant economic area is appropriately regulated to protect existing, approved or planned industrial land uses from adverse impacts associated with encroachment by non-industrial uses.

**Location of Area to which TLPI No. 1/2025 Applies**

TLPI No. 1/2025 applies only to part of the Brisbane City Council Local Government Area, namely the land identified as within the Colmslie Road Industrial Precinct boundary, which is Figure 1 to the TLPI.

I, the Honourable Jarrod Bleijie MP, Deputy Premier, Minister for State Development, Infrastructure and Planning and Minister for Industrial Relations, notify that on 13 June 2025 I have repealed TLPI 01/2023 in accordance with sections 24 and 27(3) of the *Planning Act 2016* (the Planning Act).

**Purpose and General Effect**

TLPI 01/2023 is a Temporary Local Planning Instrument (TLPI) under section 23 of the Planning Act that took effect on 19 June 2023. Under section 23(3) of the Planning Act, a TLPI may suspend or otherwise affect the operation of another local planning instrument but does not amend or repeal the instrument.

Under section 27(1) of the Planning Act, I have determined it is necessary to repeal TLPI 01/2023 and to replace it with a new TLPI will make under section 27(3) of the Planning Act immediately after TLPI 01/2023 has been repealed.
