**Rights and obligations:**

3. That the rights and obligations conferred and imposed by each easement include the matters set out in Schedule 1.

**SCHEDULE 1**

**(The Rights and Obligations to be Conferred and Imposed by the Easement)**

**DEFINITIONS**

1. In this Easement:
  - 1.1 "Acts" means the *Electricity Act 1994* and *Government Owned Corporations Act 1993* and any amendments to them or either of them or any Acts superseding those Acts.
  - 1.2 "Date of this Easement" means the date of the gazette resumption notice.
  - 1.3 "Easement" means the rights obtained from the Owner by QETC with respect to the Easement Land including but not limited to the terms and conditions contained in this Schedule.
  - 1.4 "Easement Land" means that portion of the Owner's land over which this Easement is obtained.
  - 1.5 "Owner" means the Registered Proprietor together with its successors, successors in title and assigns. Where the term appears in Clauses 3, 4, 5 and 6 it includes the servants, agents, employees, workmen and contractors of the Owner and other persons authorised by the Owner to use or enter upon the Easement Land.
  - 1.6 "QETC" means the Queensland Electricity Transmission Corporation Limited, together with its successors and assigns and others authorised by it. Where the context permits, the term includes the servants, agents, employees, workmen, linesmen, contractors of QETC and other persons authorised by QETC to use or enter upon the Easement Land.

**QETC'S RIGHTS**

2. QETC is acquiring this Easement in perpetuity to permit QETC the right to:
  - 2.1 pass and repass over the Easement Land at any time by day or by night
  - 2.2 enter upon and traverse the Easement Land, with or without vehicles, plant and equipment, if necessary, to exercise its rights under this Easement;
  - 2.3 construct and maintain a track or road on the Easement Land to a standard that QETC determines;

- 2.4 clear the Easement Land of trees, undergrowth or vegetation or any obstruction in the manner and by the means QETC considers appropriate;
- 2.5 undertake biosecurity and weed management in line with practices endorsed by Biosecurity Queensland;
- 2.5 enter upon and traverse the Easement Land for the purposes of preventing or rectifying any infringement by the Owner of QETC's rights under this Easement; and

QETC may in connection with its use and enjoyment of this Easement, exercise such of its rights, powers, discretion and functions under the Acts, or any other Act or at law as it sees fit.

#### **QETC'S OBLIGATIONS TO THE OWNER**

3. QETC will, in exercising its rights pursuant to this Easement:
- 3.1 cause as little inconvenience to the Owner as possible; and
- 3.2 act reasonably.

#### **QETC WILL COMPLY WITH SAFETY LAWS**

4. 4.1 QETC will comply with all laws regarding the use of this Easement and the safety of persons upon the Easement Land.
- 4.2 QETC will not be liable for:
- 4.2.1 the negligent acts or omissions of the Owner; or
- 4.2.2 the acts or omissions of the Owner that are a breach of this Easement or of the law

#### **THINGS THE OWNER MUST NOT DO**

5. The Owner must not interfere with or obstruct QETC in the exercise or enjoyment of its rights and powers under this Easement;

#### **OWNER MAY USE EASEMENT**

6. The Owner may use the Easement Land for any lawful purpose not inconsistent with the terms of this Easement and the rights granted to QETC.

#### **INDEMNITY**

7. QETC indemnifies the Owner against all actions, suits, proceedings, demands, costs, losses, damages and expenses arising out of or in respect of any act or omission of QETC in the use or attempted use of the Easement Land by QETC, except where such actions, suits, proceedings, claims, demands, costs, losses, damages or expenses arise as a result of any negligent act or omission of the Owner, breach of this Easement or of the law.

#### **PUBLIC RISK**

8. QETC will effect and keep current a public risk insurance policy in respect of this Easement and the use by QETC of the Easement Land for an amount which QETC considers appropriate to the public liability risk involved but in any event not less than FIFTY MILLION DOLLARS (\$50,000,000.00).

**DIRECTIVE 3/14***Supersedes: 12/13***Commission Chief Executive Directive: Senior Executive Service – Employment Conditions****1. Purpose:**

To set out the requirements for appointment and the employment conditions for officers appointed to the Senior Executive Service.

**2. Effective date:**

1 July 2014

**3. Legislative provisions:**

Section 53(b) of the *Public Service Act 2008* (PSA)

**4. Application:**

This directive applies to senior executive service officers appointed under Chapter 4, Part 2 of the PSA.

**5. Previous references:**

Directives 02/13, 05/09, 07/06, 03/06, 06/00, 01/00, 29/99, 01/99, 09/98 and 15/97.

**6. Related information:**

- Directive relating to executive remuneration package - motor vehicles
- Senior Executive Service Profile Management Procedures
- Senior Executive Service Officer Contract of Employment

**DIRECTIVE****7. Profile of and appointment to the Senior Executive Service (SES)**

- 7.1. The establishment and maintenance of the SES profile and appointment to SES roles is in accordance with Chapter 4, Part 2 of the PSA.
- 7.2. The Public Service Commission (PSC) will determine, from time to time, the administrative arrangements required to support the establishment and maintenance of the SES profile and appointment to SES roles.
- 7.3. Unless otherwise determined by the Commission Chief Executive (CCE) of the PSC, vacant SES roles must be advertised in accordance with the directive relating to recruitment and selection. In all instances, the salary quoted in vacancy advertisements must be the Total Fixed Remuneration shown in schedule one of this directive.



## 8. Attendance and hours of duty

- 8.1. The ordinary hours of duty of an SES officer may be determined by their chief executive, having regard to the health, well-being and work-life balance of the SES officer.
- 8.2. Chief executives may approve part-time work arrangements for SES officers. Part-time officers are entitled to the benefits and entitlements of full-time SES officers on a pro-rata basis.
- 8.3. SES officers are not entitled to additional compensation for work performed outside of ordinary hours (including public holidays).

## 9. Remuneration Package and Benefits

- 9.1. An SES officer shall receive remuneration in accordance with the assessed classification and work value range of their role and the applicable remuneration rates as specified in Schedule One of this directive.
- 9.2. In exceptional circumstances a contract may prescribe a variation to the remuneration and other benefits of the SES officer. Any variation must be approved by the CCE following endorsement by the chief executive.
- 9.3. The chief executive will determine the package pay-point, within the work value range for the role, that the SES officer will receive. Unless exceptional circumstances apply, the SES officer will receive remuneration at the minimum pay-point upon initial appointment. Exceptional circumstances will require support of the CCE for remuneration above the minimum pay point.
- 9.4. Any pay-point progression within the work value range must be **approved by the chief executive** and based on documented high performance in the role **or** any change to role characteristics.
- 9.5. A re-evaluation of a role changing the assessed work value from 'low' to high' within the same classification level, may, at the discretion of the chief executive, result in a change to pay-point for the SES officer.
- 9.6. An SES officer may also access the following remuneration package benefits via in-house salary packaging arrangements at no cost to the officer. The benefits must be specified in a signed agreement and cannot exceed the percentage of superannuable salary that would apply if the SES officer had been covered by the agency's fee-for-service salary packaging scheme:
  - a) the payment of employee superannuation contributions;
  - b) the payment of subscriptions for membership of professional or occupational associations;
  - c) a benefit of another kind approved by the CCE.
- 9.7. An SES officer may also access other salary packaging items from their agency's provider in accordance with the rules and charges associated with using that service.
- 9.8. A person acting as an SES officer (i.e. higher duties or temporary placement) may access the remuneration package benefits in section 9.6 provided their initial placement in the SES role exceeds 12 months.


- 9.9. The chief executive may approve the payment of transfer and appointment expenses provided the total cost of expenses is no greater than the reimbursement that would have been payable under the ministerial directive relating to transfer and appointment expenses.

#### **10. Telephone and Other Technology Benefits**

- 10.1. Unless otherwise determined by the chief executive, SES officers are to be provided with an official mobile telephone with internet / email capacity (smart phone) and are entitled to reasonable personal use of the smart phone, in accordance with departmental policy.
- 10.2. Where no official mobile telephone is provided and the chief executive considers it necessary for the SES officer to be contactable outside of hours or conduct business from home, the officer is entitled to be reimbursed for the cost of the standard base rental on one nominated telephone line in the officer's residence, and at the discretion of the chief executive, up to 50% of local calls on that line.
- 10.3. All official STD and ISD calls made from the SES officer's home telephone are to be reimbursed on production of a receipt and certification by the officer that the call was work related.
- 10.4. At the discretion of the chief executive, an SES officer may be entitled to have installed at the officer's private residence other technology necessary (e.g. computer, laptop, notebook, tablet, printer, scanner) to discharge the officer's responsibilities. These devices may be used by the SES officer for reasonable private use but remain Government property and must be returned by the officer upon cessation of employment as an SES officer. The employing department will bear the costs of installation and, as determined by the chief executive, ongoing maintenance and operation.
- 10.5. A chief executive may approve variations to the above arrangements where the chief executive considers they are insufficient for business communication needs of the SES officer. Any such variations must be clearly documented.

#### **11. Application of award provisions and directives of the Minister responsible for public sector industrial relations**

- 11.1. SES officers are entitled to the benefits and allowances set out in the following award provisions and directives of the Minister responsible for public sector industrial relations as though senior executives were covered by such directives, subject to the amendments and/or conditions noted below:
- a) *Family Leave (Queensland Public Sector) Award - State 2012*, other than clauses 1.6, 9.4 and 9.5;
  - b) the directive relating to overtime meal allowances;
  - c) the directive relating to the recognition of previous service and employment for long service leave and sick leave purposes;
  - d) the directive relating to leave without salary credit as service, but excluding provisions dealing with salary increments;
  - e) the directive(s) relating to leave, noting that:
    - (i) the amount paid by an SES officer for private motor vehicle usage will not be varied as a result of the officer entering into a purchased leave arrangement; and

- 
- (ii) provided that where the employment of an SES officer is:
- terminated by the agency prior to the completion date of the contract, other than as disciplinary action or retirement by reason of mental or physical incapacity; or
  - ended by non-renewal of the contract past the completion date,
- the number of years of continuous service required to have been completed by that officer before being entitled to the payment of salary in lieu of an entitlement to long service leave shall be one year;
- f) the directive relating to higher duties, except that:
- (i) the minimum period for relieving as an SES officer or for an SES officer acting as a chief executive, shall mean "more than two weeks";
  - (ii) the relevant percentage for relieving as an SES will be 100% unless otherwise agreed to by the CCE;
  - (iii) the relevant percentage for an SES officer acting as a chief executive will be 75% of the chief executive's superannuable salary unless otherwise determined with the approval of the CCE;
  - (iv) the clauses dealing with payment of increments during relieving periods and the recognition of higher duties on appointment shall not apply;
  - (v) the low and high range of the SES 2 and SES 3 levels shall be deemed different classification levels for the purposes of calculating higher duties allowances for an officer acting in an SES role;
  - (vi) the calculation of the higher duties allowance should be the minimum of the range unless otherwise determined by the chief executive. A decision to pay above the minimum pay-point must be documented;
  - (vii) the higher duties allowance of an SES officer approved to act in a higher SES role is to be calculated based on the difference in superannuable salary, without regard to any motor vehicle or vehicle allowance entitlements or arrangements;
  - (viii) where private use of government owned motor vehicles is not available to non-SES officers approved to act in an SES role, the higher duties allowance of such an officer is to be calculated on the difference between the employee's superannuable salary and the remuneration package value;
- g) the directive relating to court attendance and jury service;
- h) the directive relating to travelling and relieving allowances;
- i) the directive relating to locality allowances;
- j) the directive relating to critical incident entitlements and conditions, other than clauses relating to overtime, flexitime or time off in lieu;
- k) the directive relating to leave and travel concessions for isolated centres, provided that motor vehicle allowance payments do not apply where travel is undertaken in a government owned and maintained motor vehicle provided for the private use of the SES officer.

11.2. Tenured SES officers are entitled to voluntary early retirement, redundancy and retrenchment entitlements in accordance with the relevant directive.



## 12. Transitional Provision

- 12.1. An SES officer who purchased private use of a government owned motor vehicle under a superseded directive will retain it until the expiration of the current lease term on the government owned vehicle. Replacement vehicles will not be provided at the end of the lease period.
- 12.2. Where a non-SES officer has been approved to act in an SES role **and** the employee has been provided with private use of a government owned motor vehicle during the higher duties period, their higher duties allowances is to be calculated on the difference between the employee's superannuable salary and the superannuable salary of the higher duties role.

Employment Conditions****1. Purpose:**

To set out the employment conditions for senior officers.

**2. Effective date:**

1 July 2014

**3. Legislative provisions:**

Sections 53(b) and 116 of the *Public Service Act 2008* (PSA).

**4. Application:**

This directive applies to employees engaged under Chapter 5, Part 2 of the PSA at the senior officer classification level.

**5. Previous references:**

Directives: 01/13, 08/11, 06/09, 07/06, 03/06, 06/00, 01/00, 29/99, 02/99 and 02/97

**DIRECTIVE****6. Appointment as a senior officer**

- 6.1. Appointment as a senior officer will occur where the appointment is to a role assessed as being within the work value range for senior officers under the approved Job Evaluation Management System (JEMS) unless otherwise determined by the chief executive.

**7. Attendance and hours of duty**

- 7.1. The ordinary hours of duty of a senior officer may be determined by their chief executive, having regard to the health, well-being and work-life balance of the senior officer. A chief executive may approve reasonable time off without debit to a leave account where they consider the senior officer has worked in excess of their ordinary hours.
- 7.2. Chief executives may approve part-time work arrangements for senior officers. Part-time officers are entitled to the benefits and entitlements of full-time senior officers on a pro-rata basis.
- 7.3. Senior officers are not entitled to compensation for work performed outside of ordinary hours, however a meal allowance may be payable in accordance with the relevant directive.
- 7.4. A senior officer may be required by their chief executive to undertake official duties for the whole or part of a public holiday, as warranted by the circumstances.

**8. Remuneration package and benefits**

- 8.1. A senior officer shall receive remuneration in accordance with schedule one of this directive.

- 8.2. When appointing a senior officer, the chief executive will determine the relevant pay-point of the remuneration package to be paid to the senior officer, commensurate with the senior officer's skills and expertise.
- 8.3. Increases in pay-points are not tied to duration in the role. Consideration of pay-point increases by the chief executive must be based on sustained performance that exceeds expectations. Increased duties or responsibilities will not be relevant to a change in pay-point as the role of senior officer is deemed to be within a work value range.
- 8.4. Senior officers may elect, through a signed agreement with their chief executive, to receive the following remuneration package benefits via in-house salary packaging at no cost to the officer:
  - a) the payment of employee superannuation contributions
  - b) the payment of subscriptions for membership of professional or occupational associations
  - c) any other benefit of a kind approved by the Commission Chief Executive of the Public Service Commission.
- 8.5. A remuneration benefit agreed in section 8.4 must not exceed the percentage of the superannuable salary that would apply if the senior officer was to access the agency's fee for service salary packaging scheme.
- 8.6. A senior officer may also access other salary packaging items from their agency's provider in accordance with the rules and charges associated with using that service.
- 8.7. A person acting as a senior officer (i.e. higher duties or temporary employee) may access the remuneration package benefits provided their initial placement in the senior officer role exceeds 12 months.

#### **9. Telephone and other technology**

- 9.1. Where determined by the chief executive, senior officers are to be provided with an official mobile telephone with internet / email capacity (smart phone) and are entitled to reasonable personal use of the smart phone, in accordance with departmental policy.

#### **10. Application of award provisions and directives of the Minister responsible for public sector industrial relations.**

- 10.1. Senior officers are entitled to the benefits and allowances set out in the following award provisions and directives of the Minister responsible for public sector industrial relations as though senior officers were covered by such directives, subject to the amendments and/or conditions noted below:
  - a) *Family Leave (Queensland Public Sector Award) State 2012*, other than clauses 1.6, 9.4 and 9.5; and
  - b) the directive relating to critical incident entitlements and conditions, other than clauses relating to overtime, flexitime or time off in lieu.
- 10.2. The application of the directive relating to higher duties is varied for senior officers on the following basis:
  - a) the minimum period shall mean "more than three days";
  - b) the relevant percentage will be 100%;
  - c) the clauses dealing with payment of increments during relieving periods and the recognition of higher duties on appointment shall not apply; and

- d) the calculation of the higher duties allowance should be the minimum of the range unless otherwise determined as warranted by the chief executive. A decision to pay above the minimum pay-point must be documented.
- 10.3. A senior officer may be provided with benefits under the directive relating to transfer and appointment expenses. Alternatively, transfer and appointment expenses may be paid in accordance with a proposal approved by their chief executive, and supported by a certificate from the chief executive that the total quantum for expenses under the proposal will be no greater than the reimbursement that would have been payable under the directive.

## SCHEDULE 2

The Schedule 5 Conditions and Schedule 5A Conditions published in the Gazette of 28 July 2006 are omitted and replaced with the following:

## SCHEDULE 5 CONDITIONS

**1. The types of Motor Vehicles liable for tolls for use of Clem7.**

1.1 The following types of Motor Vehicles are liable for tolls:

- (a) Cars;
- (b) Motorcycles;
- (c) Light Commercial Vehicles; and
- (d) Heavy Commercial Vehicles.

**2. The maximum toll payable for use of Clem7 for each type of Motor Vehicle liable to pay a toll.**

2.1 The maximum toll payable for each type of Motor Vehicle is the amount specified below as modified from time to time by operation of the formula contained in condition 3.

Type of Motor Vehicle	Base Maximum Toll (GST Inclusive)
Cars	\$4.72
Motorcycles	\$2.36
Light Commercial Vehicles	\$7.08
Heavy Commercial Vehicles	\$12.50

The Base Maximum Tolls are based on prices applied for the 6 month period commencing on 1 January 2014 and ending on 30 June 2014.

2.2 If a Motor Vehicle would normally be classified as a "Light Commercial Vehicle", the owner of a Light Commercial Vehicle may provide evidence of that Motor Vehicle being registered for personal use (and not commercial use) in which case the toll will be that charged for Cars.

2.3 The Base Maximum Toll for Exempt Buses shall be fixed at \$0.

**3. The methodology to be used to decide indexed, periodic increases in the maximum toll payable for use of Clem7.**

3.1 The Theoretical Toll will be adjusted on 1 July 2014 and every anniversary of 1 July thereafter in accordance with the following methodology:

Theoretical Toll<sub>n</sub> = (CPI<sub>n-1</sub> ÷ CPI<sub>Base</sub>) x Base Maximum Toll.

Provided that:

- (a) During the Tolling Period the Theoretical Toll<sub>n</sub> cannot be less than Theoretical Toll<sub>n-1</sub>.
- (b) Certain types of Exempt Vehicles are exempt by Legislation from tolls when using the Tollway.

Where:

- (a) Theoretical Toll<sub>n</sub> = the Theoretical Toll for the current financial year which is the maximum toll payable in that year for each type of Motor Vehicle;
- (b) Theoretical Toll<sub>n-1</sub> = the Theoretical Toll for the immediately preceding financial year;
- (c) CPI<sub>n-1</sub> = at any date, is, the CPI for the quarter ending 31 March of the immediately preceding financial year; and
- (d) CPI<sub>Base</sub> = 103.8 being the CPI for the Quarter expiring on 30 September 2013.

- 3.2 The All Groups Consumer Price Index Brisbane published quarterly by the Australian Bureau of Statistics will be used as the index for determining CPI. If the All Groups Consumer Price Index Brisbane is no longer published then the Local Government can adopt an alternative that is approved in writing by the Minister.
- 3.3 The Theoretical Toll<sub>n</sub> is the maximum that can be charged as a toll in the current financial year and lesser charges are acceptable.
- 3.4 Where a Theoretical Toll<sub>n</sub> calculated in accordance with section 3.1 is not a multiple of whole cents, the Theoretical Toll<sub>n</sub> shall be rounded to the nearest whole cent (rounding upwards amounts ending in 0.5cents).
- 3.5 The Local Government must give the public a minimum of 5 Business Days' notice of any change to a toll that will become payable on Clem7 by placing a notice in a Newspaper.
- 4. The day the toll becomes payable by each type of Motor Vehicle liable to pay a toll for use of Clem7.**
- 4.1 Any tolls, Administration Charges and User Administration Charges may only be levied after the Minister has been provided with signed copies of the Independent Verifier's Certification of Tollroad Completion and Tolling System Completion.
- 4.2 The Local Government must give the public a minimum of 3 Business Days' notice of the date when a toll becomes payable on Clem7 by placing a notice in a Newspaper.
- 5. The Administration Charge payable for issuing a notice for, and collecting, an unpaid toll for use of Clem7.**
- 5.1 The Local Government must give the public notice of the date when an Administration Charge becomes payable on Clem7 by placing a notice in a Newspaper.
- 5.2 The quantum of the Administration Charge must be reviewed by an Independent Auditor for the purpose of certifying that the Administration Charge reflects the reasonable cost of issuing a notice for, and collecting an unpaid toll for Clem7, no less than two years after the Tollway becomes operational and no less than once every five years after the initial review. The cost of the Independent Auditor will be paid by the Local Government. This condition does not limit any statutory requirement contained in the Legislation that may require more frequent reviews.
- 6. The ways of making payment of the toll liability for use of Clem7, other than by use of the E toll system.**
- 6.1 The Local Government must provide customers or cause customers to be provided with a broad range of tolling products and methods of payment for toll liability including the ability to pre-pay and post-pay tolls.
- 6.2 Post-pay toll products must provide for no less than 72 hours for payment of tolls.
- 6.3 The Local Government must give the public notice of the ways of making payment of the toll liability in a notice in a Newspaper prior to the commencement of tolling
- 6.4 Any alteration to the ways of making payment of the toll liability must be publicly disclosed in a notice in a Newspaper no less than 5 Business Days' prior to such alteration taking effect.
- 7. The User Administration Charge payable for persons making payment of the toll other than by use of the E toll system.**
- 7.1 The Local Government must give the public notice of the date when User Administration Charges become payable on Clem7 by placing a notice in a Newspaper.
- 7.2 The quantum of the User Administration Charge must be reviewed by an Independent Auditor for the purpose of certifying that the User Administration Charge reflects the reasonable cost of administering and collecting payment of the toll, other than by use of the E toll system, no less than two years after the Tollway becomes operational and no less than once every five years after the initial review. The cost of the Independent Auditor will be paid by the Local Government. This condition does not limit any statutory requirement contained in the Legislation that may require more frequent reviews.
- 8. A description of the arrangements that will be used to allow users of Clem7 to satisfy the liability to pay tolls on the Tollway and tolls on other tollroads or local government tollways in the State or another State**
- 8.1 The Local Government must use its best endeavours to ensure that the Tolling System for Clem7 operates on an interoperable basis with other tollroad service providers for other Australian tollroads and/or tollways under an Interoperability Agreement.
- 8.2 Nothing in this Declaration permits a toll, Administration Charge or User Administration Charge to be levied on a road user of Clem7 in excess of the parameters established in the Act and this Declaration despite any provision to the contrary in any Interoperability Agreement.

**9. The day the toll stops being payable, or a method to work out the day that the toll stops being payable, by each type of Motor Vehicle liable to pay a toll for use of Clem7.**

9.1 The day the toll stops being payable is at the end of the Tolling Period.

#### SCHEDULE 5A CONDITIONS

### **1. Traffic management by the Local Government**

1.1 The Local Government must maintain one or more free alternative routes for the transit of Motor Vehicles that supply viable free access for the public to and from the same general geographical regions that are connected by Clem7. The service provided by the free alternative route must be of an acceptable standard in the context of the overall road network in Brisbane.

1.2 The free alternative route described in condition 1.1 of the Schedule 5A Conditions must be easily accessible by all road users.

1.3 The Local Government must ensure that highly visible signage (in accordance with the Manual of Uniform Traffic Control Devices published by the Department of Transport and Main Roads) is provided so that road users approaching Clem7 from any direction are aware of the free alternative route and of the requirement to pay a toll for the use of Clem7.

### **2. Management by the Local Government of the impact of Clem7 on the road network**

2.1 From the date of the Gazette Notice declaring the land Local Government Tollway Corridor Land, the Local Government must obtain written approval from the Director-General of the Department of Transport and Main Roads if:

(a) it intends to carry out road works on Clem7 and the local government roads which provide egress to and exit from the Clem7, or make changes to the management of those roads, and

(b) the works or changes would –

(i) require the carrying out of road works on a State-controlled road; or

(ii) otherwise have a significant adverse impact on a State-controlled road; or

(iii) have a significant impact on a planned State-controlled road.

2.2 The Local Government must apply to the Director-General of the Department of Transport and Main Roads to obtain the Director-General's written approval to make a change to the management of Clem7 and the local government roads which provide egress to and exit from the Clem7 that, if made, would have a significant adverse impact on the provision of a Public Passenger Service.

2.3 To remove any doubt, the Director-General of the Department of Transport and Main Roads has sole discretion to determine what may amount to or constitute a significant adverse impact for the purposes of conditions 2.1 and 2.2 of the Schedule 5A Conditions.

2.4 The Local Government will not make any changes to the local government road network that are designed to improve the commercial viability of Clem7 to the detriment of the transport network. The Local Government may make changes to the local road network where it is clearly justifiable and provides a positive transport network outcome.

### **3. Reports from Local Government about Clem7**

3.1 The Local Government will provide, annually and at such other time as requested by the Minister, a report in writing to the Minister on the operation of Clem7 and compliance with conditions of this approval, other conditions set by the Government and any Legislation or law that impacts on Clem7. Any information requested by the Minister may be made available to the public.

3.2 The report described in condition 3.1 of the Schedule 5A Conditions must include details of the following:

(a) the outcome of reviews of the Administration Charge and the User Administration Charge;

(b) any increases in toll levels;

(c) current toll levels for all types of Motor Vehicles;

(d) identification of the free alternative route required by condition 1;

(e) identification of any changes to the local government network that may have a direct impact on the commercial viability of Clem7; and

(f) any other matter or thing that the Minister may request from time to time.

3.3 The Local Government must provide a report to the Minister immediately after:

- (a) any significant incident, event, and/or Motor Vehicle crash occurs on Clem7 that adversely impacts on the State-controlled road network; and/or
- (b) any significant damage is caused to Clem7; and/or
- (c) any significant defect is found in the construction of Clem7 or the Tolling System.

#### DEFINITIONS FOR SCHEDULE 5 AND SCHEDULE 5A CONDITIONS

### 1. Definitions

1.1 In these Conditions:

**“Act”** means the *Transport Infrastructure Act 1994* and includes any amendment or replacement of this Act.

**“Administration Charge”** and **“User Administration Charge”** have the same meaning as is provided in the Act.

**“Bus”** means a Motor Vehicle having more than 12 seating positions (including the seating position used by the driver).

**“Business Day”** means a day in Brisbane that is not a Saturday, Sunday or a public holiday and on which banks are generally open for business.

**“Car”** means a Motor Vehicle, including a Taxi, other than a Motorcycle or a Commercial Vehicle (even if such a Motor Vehicle is towing a trailer or caravan).

**“Commercial Vehicle”** means a Motor Vehicle that is either a Light Commercial Vehicle or a Heavy Commercial Vehicle.

**“E toll system”** means an electronic system operated by a tollroad operator for the recording, or the recording and meeting, of liability for a toll for use of the tollroad.

**“Exempt Bus”** means a Bus which is:

- (a) operated by the Brisbane City Council; or
- (b) funded by the State for the provision of Scheduled Passenger Service.

**“Exempt Vehicle”** means:

- (a) a police vehicle;
- (b) an ambulance;
- (c) a fire engine or similar vehicle;
- (d) an Emergency Services (ES) vehicle or a State Emergency Services (SES) vehicle (as those terms are defined in the *Disaster Management Act 2003* (Qld));
- (e) a vehicle being utilised in the performance of emergency services under authority of a State Law or the State;
- (f) an Exempt Bus; or
- (g) any other vehicle that is prescribed under the law to be exempt from liability for payment of tolls.

**“Heavy Commercial Vehicle”** means a Motor Vehicle that:

- (a) is a rigid Truck with three or more axles;
- (b) is an articulated Truck;
- (c) is a Bus;
- (d) is a two axle rigid Truck having a gross vehicle mass greater than 4.5 tonnes;
- (e) is a Motor Vehicle having a gross vehicle mass greater than 30 tonnes; or
- (f) has spatial dimensions which are substantially consistent with one or more of the criteria in paragraphs (a) to (e) above.

**“Independent Auditor”** means an auditor chosen by both the Local Government and the State working together and acting reasonably. If the Local Government and the State do not agree within a reasonable time regarding the appointment of an auditor, the State will appoint the auditor. The qualifications of an auditor must be either:

- (a) a person registered as an auditor under the *Corporations Act*; or

- (b) a member of the Australian Society of Certified Practising Accountants or the Institute of Chartered Accountants in Australia; or
- (c) a person who holds a public practising certificate issued by the National Institute of Accountants and has completed a tertiary course of study in accounting with an auditing component from an institute prescribed under the *Corporations Act*, section 1280(2).

**“Independent Verifier”** means the unincorporated joint venture between David Langdon Australia Pty Ltd and SMEC Australia whose role includes determining whether or not Tollroad Completion and Tolling System Completion has been achieved and, if Tollroad Completion and Tolling System Completion have been achieved, issuing the relevant Certificate of Completion. The Local Government can adopt an alternative Independent Verifier that is approved in writing by the Minister.

**“Independent Verifier’s Certification”** means the certification from the Independent Verifier to be provided to the Local Government to evidence that the Tollroad and the Tolling System have reached practical completion.

**“Interoperability Agreement”** means one or more agreements that provide for interoperable tolling between Clem7 and other Australian tollroads which allows any tollroad users to travel efficiently, reasonably and effectively on all tollroads around Australia.

**“Legislation”** means all Queensland Acts of Parliament and any Federal Acts of Parliament as well as any subordinate legislation including, without limitation, any amendment or new Act that may be proclaimed in the future.

**“Light Commercial Vehicle”** means, subject to condition 2.2 in the Schedule 5 Conditions, a Motor Vehicle that:

- (a) is a two axle rigid Truck or load carrying van or utility, having a gross vehicle mass greater than 1.5 tonnes but not exceeding 4.5 tonnes; or
- (b) has spatial dimensions which are substantially consistent with the axle and mass criteria in paragraph (a) above.

**“Local Government”** means the local government which requested that the Minister declare Clem7 a local government tollway pursuant to section 105GA of the Act.

**“Local Government Tollway Franchise Agreement”** is an agreement referred to in section 105Y of the Act which will be tabled in accordance with section 105Z(1) of the Act.

**“Minister”** means the Minister for the time being with portfolio responsibility for the relevant sections of the Act.

**“Motorcycle”** means a two wheeled Motor Vehicle, whether or not a sidecar is attached to it

**“Motor Vehicle”** has the meaning given to it in the *Transport Operations (Road Use) Management Act 1995*.

**“Newspaper”** means a printed news service that is commonly available to the public in Brisbane and has a wide circulation. In the future, it is contemplated that newspapers may be replaced by other types of mass media such as mobile downloads. The State can give a written direction to the Local Government to adopt a new form of advertising to replace Newspaper advertising at any time, acting reasonably.

**“Public Passenger Service”** means a service for the carriage of passengers if:

- (a) the service is provided for fare or other consideration; or
- (b) the service is provided in the course of trade or business (but not if it is provided by an employer solely for employees); or
- (c) the service is a courtesy or community transport service; and includes a driver service and a service for the administration of taxi services but does not include a service excluded from the *Transport Operations (Passenger Transport) Act 1994* by a regulation.

**“Scheduled Passenger Service”** has the meaning given to it in the *Transport Operations (Passenger Transport) Act 1994*.

**“Taxi”** means a Motor Vehicle registered with the Queensland Department of Transport and Main Roads for use as a taxi.

**“Theoretical Toll”** means the maximum that can be charged as a toll for each type of Motor Vehicle in each financial year calculated in accordance with condition 3.

**“Tollroad Completion”** means the stage when the Tollroad (excluding the Tolling System) and everything else necessary to open the Tollroad (excluding the Tolling System) for the safe, efficient and continuous passage of vehicles is complete except for minor defects which:

- (a) do not prevent the Tollroad (excluding the Tolling System) from being reasonably capable of being used for its intended purpose;
- (b) the Independent Verifier determines there are reasonable grounds for delay in rectification; and
- (c) can be corrected without prejudicing the convenient use of the Tollroad (excluding the Tolling System) for the safe, efficient and continuous passage of vehicles.



**“Tollway”** means the physical works, facilities, systems (including the Tolling System) and public utility plant described as being required for the Tollway called Clem7.

**“Tolling Period”** means 45 years from the earlier of the following dates:

- (a) the date of financial close under the terms of the Local Government Tollway Franchise Agreement dated 24th of May 2006 in respect of Clem7; and
- (b) 30th September 2006.

**“Tolling System”** means the physical hardware, software, firmware and other aspects of the system proposed to be used or in use, as the case may be at any particular time for the levying and collection of tolls. This includes any billing systems, operating systems, customer relationship management systems (including any call centre procedures and systems) and any other ancillary systems that are necessary for the full operation of the Tolling System.

**“Tolling System Completion”** means the stage when Tollroad Completion has been achieved and the Tolling System is installed and operational except for minor defects that may remain, where those defects:

- (a) do not prevent the Tolling System from being reasonably capable of being used effectively and accurately for its intended purpose;
- (b) do not prevent the Tollroad from being reasonably capable of being used effectively for its intended purpose;
- (c) the Independent Verifier determines that the defect can, on reasonable grounds, await rectification; and
- (d) can be rectified without prejudicing the convenient use of the Tolling System and the Tollroad.

**“Truck”** means a Motor Vehicle other than a Bus which has a cab-chassis construction and a gross vehicle mass greater than 1.5 tonnes.

- 1.2 Words indicating the singular number shall include the plural number and vice versa.
- 1.3 Words indicating a gender shall include all other genders.
- 1.4 Reference to a person shall include an individual, corporation or other entity recognised by law and where the person is referred to by title, includes a person that has assumed the responsibilities of that person whether or not the title remains the same.
- 1.5 Reference to a statute, regulation, ordinance or local law shall be deemed to extend to all statutes, regulations, ordinances or local laws amending, consolidating or replacing them.
- 1.6 A reference to a condition is a reference to a condition in this declaration and includes any amendments to them made in accordance with this declaration.
- 1.7 In the absence of any condition to the contrary, references to Clem7, include any part of Clem7.
- 1.8 References in this Declaration to “tollroad” includes a reference to a “local government tollway”. The words are used to include both tollroad and tollway as the case may be and, without limitation, both where the context permits.

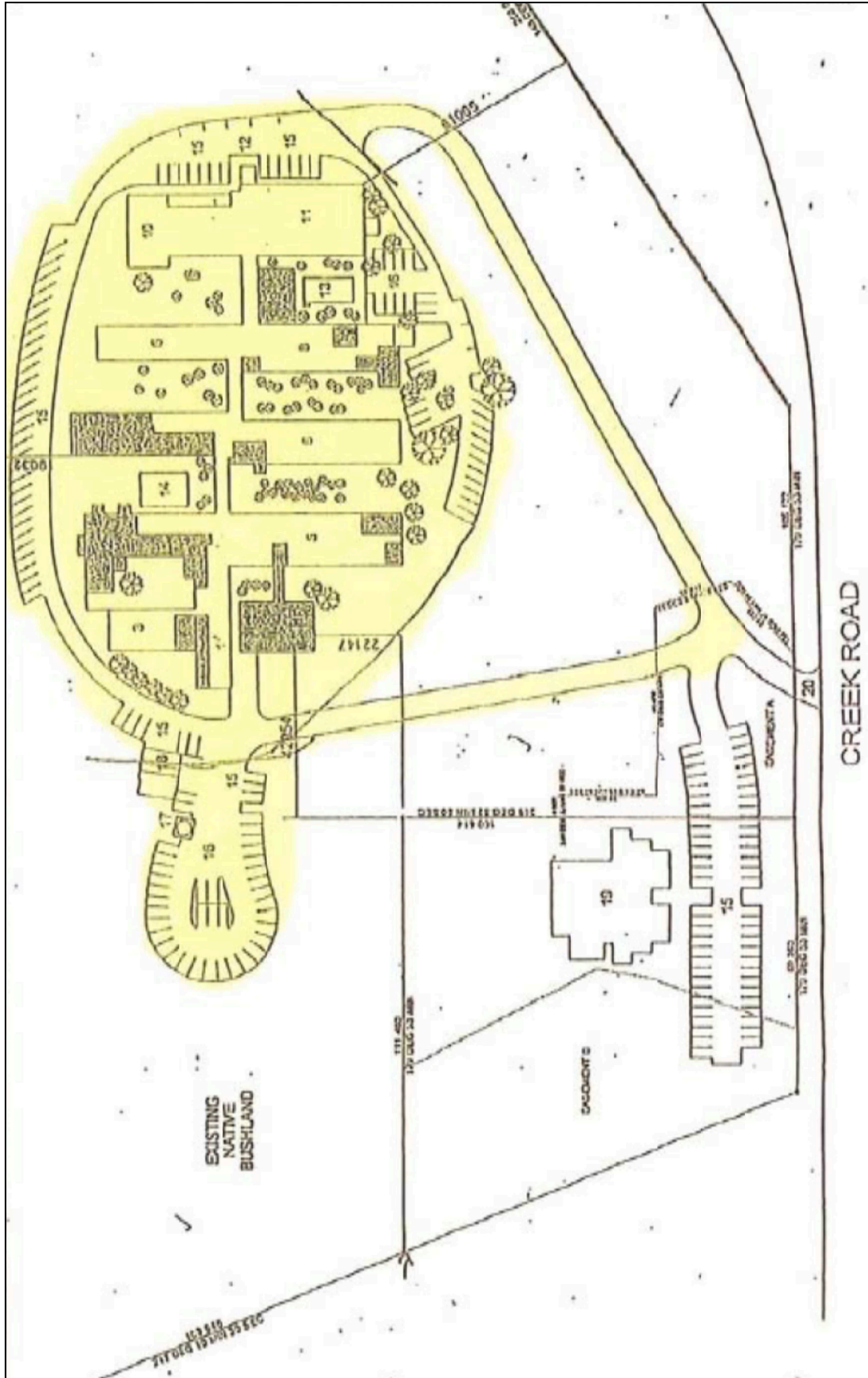

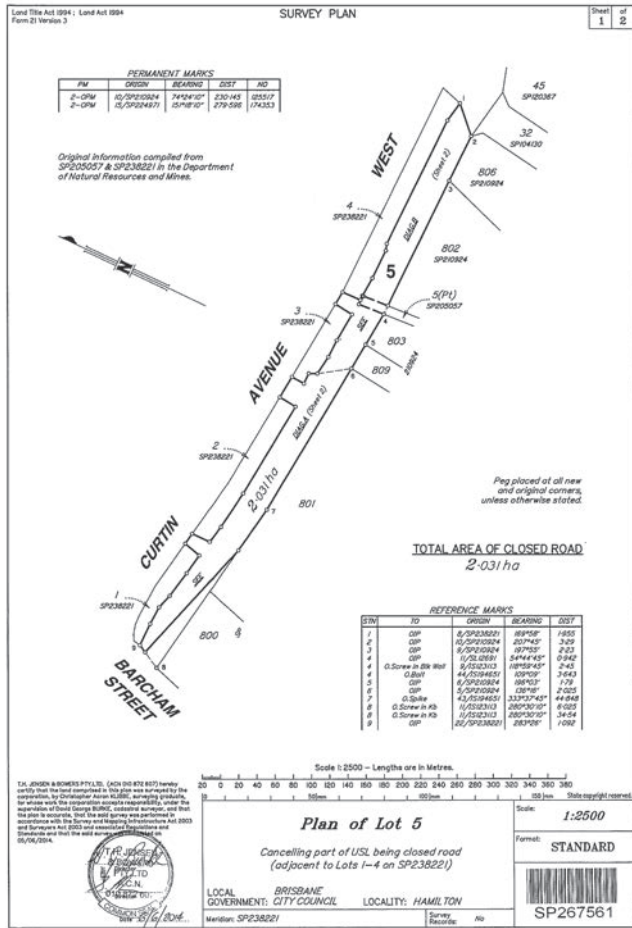
