This notice revokes and replaces the "Notification of Danger to Marine Safety" on page 290 in Queensland Government Gazette No. 29 published 28 February 2025.

**I, Captain Frank D'Souza, Harbour Master, Maritime Safety Queensland (MSQ)**, pursuant to Section 197(2) of the *Transport Operations (Marine Safety) Regulation 2016*, state that the anchoring, berthing, mooring or operation of a ship (other than a ship operated by or exempted by the entities listed in Column 2) in the waters described in Column 1 for the periods of 1 hour prior, and 30 minutes after, each space launch from Bowen Orbital Spaceport, Bowen, endangers marine safety.
