Townsville City Council has, by resolution dated the 23 February 2022, made *Local Law No. 9 (Stadium Parking Area) 2022* and *Subordinate Local Law No. 9 (Stadium Parking Area) 2022*.

Purpose and general effect

1. The purpose and general effect of *Local Law No. 9 (Stadium Parking Area) 2022* and *Subordinate Local Law No. 9 (Stadium Parking Area) 2022* is to protect and enhance local amenity by—
 - (a) providing for Council's regulation of parking by time in part of the City (a "parking area") when that is desirable because of an event at the North Queensland Stadium.
2. *Local Law No. 9 (Stadium Parking Area) 2022* and *Subordinate Local Law No. 9 (Stadium Parking Area) 2022* does not contain any anti-competitive provisions.
