

# QUEENSLAND CORRECTIVE SERVICES INSTRUMENT OF DELEGATION OF CHIEF EXECUTIVE POWERS

#### SHORT TITLE

This instrument may be cited as the Instrument of Delegation of Chief Executive Powers (Instrument).

#### SCOPE OF DELEGATION

This Instrument delegates to persons set out in the attached schedules the powers vested in the Chief Executive, Queensland Corrective Services in relation to:

Powers under the Corrective Services Act 2006

Schedule 1

Public Service Act 2008 (powers under other Acts)

Schedule 2

Powers under the Youth Justice Act 1992

Schedule 3

All delegations must be exercised in accordance with relevant policies and procedures of Queensland Corrective Services, including any financial authority and approval.

Exercise of the delegated powers is to be in accordance with any limits and conditions specified in the accompanying schedules.

#### **DATE OF EFFECT**

The commencement date of this Instrument is Asy day of January 20

This Instrument revokes all former instruments of delegations in relation to the same powers or functions which are covered by this Instrument.

### **SCHEDULE 1**

## Delegation of Statutory Powers Corrective Services Act 2006

Pursuant to section 271(1) of the *Corrective Services Act 2006* (CSA), I, Paul Stewart APM, Chief Executive and Commissioner, Queensland Corrective Services delegate the powers in the sections of the CSA listed in Column 1 to the Officer or Officers listed in Column 2, subject to relevant limitations and conditions listed in Column 3.

In making this delegation, I have considered the requirement of section 271 of the CSA that delegates must be appropriately qualified persons as defined in section 271(3) of the CSA.

For the purpose of this Instrument:

Where the title of an office changes, but the duties, functions and responsibilities of the office remain substantially the same, then a reference to the title of the office below is a reference to the changed title of the office.

References to statutes are to be construed as including all statutory provisions, consolidating, amending or replacing the statute referred to and all regulations, rules, proclamations, orders, prescribed forms and other authorities pursuant thereto.

All delegations must be exercised in accordance with relevant policies and procedures of Queensland Corrective Services, including financial authority and approval (where relevant). Exercise of the delegated powers is to be in accordance with any limits and conditions specified in this schedule.

"Deputy Commissioner" means any officer within Queensland Corrective Services whose title includes 'Deputy Commissioner', unless this Instrument of Delegation limits the delegate to a specific Deputy Commissioner or Deputy Commissioners.

"Assistant Commissioner" means any officer within Queensland Corrective Services whose title includes 'Assistant Commissioner', unless this Instrument of Delegation limits the delegate to a specific Assistant Commissioner or Assistant Commissioners.

"Community Corrections Officer" means a QCS officer who works in a Community Corrections setting and holds the position of any of 'Case Manager', 'Senior Case Manager', 'Court Advisory Officer' or 'Probation Services Officer'.

"Corrective services facility" has the meaning set out in the Corrective Services Act 2006.

"Manager, High Risk Offender Management Unit" means a QCS officer within the High Risk Offender Management Unit and who holds the position of 'Manager, Electronic Monitoring and Surveillance Unit', 'Manager, Strategy and Risk', 'Manager, Central and Far North Queensland', or 'Manager, South East Queensland'.

#### SCHEDULE 2

# Delegation of Statutory Powers Public Service Act 2008

Under section 103(1) of the <u>Public Service Act 2008</u> the chief executive may delegate chief executive powers under any Act to any appropriately qualified person. "Manager, High Risk Offender Management Unit" means a QCS officer within the High Risk Offender Management Unit and who holds the position of 'Manager, Electronic Monitoring and Surveillance Unit', 'Manager, Strategy and Risk', 'Manager, Central and Far North Queensland', or 'Manager, South East Queensland'.

All delegations must be exercised in accordance with relevant policies and procedures of Queensland Corrective Services, including financial authority and approval (where relevant). Exercise of the delegated powers is to be in accordance with any limits and conditions specified in the accompanying schedules labelled "A through to N".

Where the title of an office changes, but the duties, functions and responsibilities of the office remain substantially the same, then a reference to the title of the office below is a reference to the changed title of the office.
