Petroleum and Gas (Royalty) Regulation 2021 Section 49(3)

Application by tenure holder to end election period for non-tenure holder

About this form

This form is for a person (the relevant tenure holder) who:

- is a participant in a joint venture or other arrangement involving the production of petroleum (the joint venture)
- is a registered holder of one or more of the petroleum tenures under which the petroleum for the joint venture is produced (each, a joint venture tenure)
- has previously been notified by the Commissioner of State Revenue that a person (the non-tenure holder) is taken to be a petroleum producer—for petroleum royalty purposes only—for a period of time (the election period) for a stated amount of petroleum produced under one or more joint venture tenures, as a result of a decision by the Commissioner under s.48(4) Petroleum and Gas (Royalty) Regulation 2021
- wishes to apply to end the election period.

The relevant tenure holder may apply to end the election period even if the non-tenure holder is not taking a share of petroleum to which the relevant tenure holder is entitled as a registered holder of a joint venture tenure.

The application cannot be considered by the Commissioner unless it is accompanied by evidence that you have notified the following persons of the application:

- the non-tenure holder
- each other registered holder of a joint venture tenure.

The Commissioner may:

- end the election period on the day proposed in this application
- end the election period on another day, with the agreement of you, the non-tenure holder and any other registered holders of a joint venture tenure
- refuse to end the election period.

The election period can only be ended if the Commissioner is satisfied that the protection of the public revenue would not be adversely affected.
