### Part 1 - Introduction

#### 1. Purpose of the guideline

This safe movement guideline provides exemptions for **eligible** light vehicles to remain as left-hand drive vehicles when accessing the road network in Queensland.

#### 2. How this guideline should be used

This guideline is designed to assist customers that wish to operate a left-hand drive vehicle that is at least 25 years old and imported under the appropriate provisions of the Road Vehicle Standards Act 2018.

#### 3. Guideline authority

This guideline is issued under the *Transport Operations (Road Use Management—Vehicle Standards and Safety) Regulation 2021* section 53, in accordance with the Statutory Instruments Act 1992 section 22.

#### 4. Definitions

Unless otherwise stated, words and expressions used in the guideline have the same meanings as those defined in the *Transport Operations (Road Use Management) Act* 1995 or the *Transport Operations (Road Use Management – Vehicle Standards and Safety) Regulation 2021.* 

**ADR** means the Australian Design Rules, the national standards for vehicle safety, anti-theft and emissions.

Build date means the later date of either:

- The month and year that assembly of the vehicle was first completed/manufactured (where only the year of manufacture can be identified, the month will be taken to be December of that year); or
- If significant modifications have been made to the vehicle, the date the last significant modification was completed.

**VSS Regulation** means the *Transport Operations* (Road Use Management – Vehicle Standards and Safety) Regulation 2021.

#### 5. Exemptions to vehicle standards

Vehicles operating under this guideline are exempt from the vehicle standards requirements noted in **Table 1**.

## Part 2 - General Requirements

#### 1. Eligible light vehicle categories

- 1.1 An eligible light vehicle means a motor vehicle that meets the following requirements:
- 1.1.1 The vehicle has a build date that is at least 25 years before the date of application for registration.
- 1.1.2 The vehicle is of one of the ADR vehicle categories as noted in **Table 2**.

#### Table 2 – Eligible light vehicle categories

Vehicle category (description)	ADR category code
Passenger car	МА
Forward-control passenger vehicle	MB
Off-road passenger vehicle	MC
Motor tricycle	LE
Light goods vehicle	NA

- 1.1.3 The vehicle has:
  - (a) been issued, after 10 December 2019, with an appropriate Import Approval under Regulation 11 of the *Motor Vehicle Standards Regulation 1989* (Commonwealth); or
  - (b) been provided a concessional RAV entry approval under section 35 and 36 of the *Road Vehicle Standards Rules 2019* (Commonwealth).
