Liquor and wine licence fees and charges 2025–2026



Overview of Queensland liquor and wine licence fees and charges

All liquor licences in Queensland are subject to a base fee plus any additional fee calculated by the risk criteria. The risk criteria relate to trading hours, service practices and compliance history.

Our fees and charges increase on 1 July each year. On 1 July 2025, our fees and charges were increased by 3.4% in line with Government's indexation policy. You can contact us to find out details about specific fees, charges, or prices.

Annual fees are payable by 31 July each year. The liquor licence will be automatically suspended, and then cancelled after 28 days, if the fee remains outstanding. The wine licence will be automatically suspended and cancelled after 14 days if the fee remains outstanding.

If your liquor licence is cancelled, your gaming licence will be automatically cancelled. If this occurs, gaming activities must cease. Your licensed monitoring operator will be advised to disable all gaming machines. All hotel operating authorities or club entitlements will be forfeited to the state, with no opportunity for redress. If this occurs, licensees have to reapply for a gaming licence and purchase new operating authorities or entitlements at market rates.
