Applications can be made in relation to camera-detected fines issued by the Road Safety Camera Office, the Department of Transport and Main Roads, Queensland Revenue Office or for tolling offences.

SPER is unable to consider withdrawal of a fine if it was issued by a court or council, or was issued in person (e.g. a traffic infringement notice issued to the applicant in person by a Queensland police officer).
