#### QUEENSLAND REDISTRIBUTION COMMISSION INVITATION FOR SUGGESTIONS

The Queensland Redistribution Commission is undertaking a redistribution of the electoral boundaries of the State's 93 electoral districts.

In accordance with section 42 of the *Electoral Act 1992*, the Commission invites written suggestions from all interested persons and bodies, relating to the boundaries or names of electoral districts.

Suggestions can be lodged for a period of 30 days and must be received by the Commission by Wednesday, 6 August 2025.

Suggestions must be in writing and can be lodged by:

- Mail: Queensland Redistribution Commission
  - GPO Box 1393, BRISBANE QLD 4001

Under section 43 of the *Electoral Act*, the Commission is required to make available for public inspection all suggestions received during the consultation period. The Commission has released guidelines on making a submission, including how submitters' personal information will be managed when submissions are published.

In preparing its proposed redistribution, section 45 of the *Electoral Act* requires the Commission to ensure electoral districts remain within specified enrolment limits. Further information about current and projected enrolment, factors that must be considered by the Commission and the redistribution process is outlined in the discussion paper released to support the invitation for suggestions.

Submitters are encouraged to review the discussion paper, submission guidelines and enrolment statistics available at **www.redistribution.ecq.qld.gov.au** when making a submission.

"**Performance Securities**" means any indemnity, bank guarantee, security bond, deposit and other securities for the performance of obligations given in favour of the State (represented by Queensland Health) in respect of the Transferred Property or Ancillary Instruments but do not include rights or securities in relation to the rectification of defects in connection with the carrying out of Major Capital Works;

"**Possession Date**" means the Date of Practical Completion or such later date on which the Service is granted possession of the Transferred Property;
