



The Queensland Public Service is committed to equal opportunity in employment. Selection will be given on the basis of merit only and fair consideration will be given to all applicants. The Queensland State Government's policy is to seek to retain skilled staff. Registered deployees who apply for an advertised job will be considered before other applicants. The symbol (h) appears next to vacancies where an exemption from this requirement applies. Deployees are to indicate in their application for the advertised job that they are registered with the Office of the Public Service Commission. The Queensland Public Service Commissioner is committed to equal opportunity in employment. Selection will be given on the basis of merit only and fair consideration will be given to all applicants.

CONTINUOUS APPLICANT POOLS

A continuous applicant pool allows you to apply for jobs within an occupation where vacancies are regularly available. This means that agencies can 'dip' into the pool for suitable applicants as soon as they have a vacancy. You can submit or refresh your application at any time. If you are refreshing your application, make sure that you indicate this either on your email or, if sending by post, in a covering letter. In search results, continuous applicant pools can be identified by 'Ongoing' in the 'Closes' column of a search result.

Note: If a continuous applicant pool is closing, applicants will be notified two weeks prior to this date. Applications may be used for up to six months after the pool closes.

MULTI-AGENCY POOLS

Some Queensland Government agencies are on the lookout for people to fill similar jobs or occupations at the same time. Some of these jobs have a fixed closing date and others are ongoing (continuous applicant pools). With multi-agency pools, you only have to apply once to access job opportunities across participating agencies. Your application will then be able to be viewed and assessed by all the agencies in that pool - or, if you prefer, you can specify that you want to be considered only for particular agencies. Make sure you check the specific vacancy to find out how each pool works.


HOW TO APPLY

When you have found the job you would like to apply for.

- 1. You can phone for a copy of the information kit or you can download the documents from the Smart Jobs and Careers website at www.jobs.qld.gov.au. The information kit will include:
 - the position or job description detailing: background of the department or work area; roles and responsibilities, and selection criteria
 - a job information package, outlining the procedure for preparing and sending in your application, and
 - an application cover sheet.
- 2. Do your homework research the agency to understand the background to the job.
- 3. Prepare your application. This should include your:
 - completed cover sheet (available on jobs online or in the kit mailed to you)
 - covering letter
 - resumé / curriculum vitae
 - names and contact details of (2) referees, and
 - responses to the selection criteria if required.
- 4. Mail or email your application (Details of where and how are available in either the job description or the job information package.

Check with the job vacancy contact person if you are unsure about how or where to submit your application or how many copies to send. Make sure you send your application by the closing date. If you don't, it may not be accepted. Once your application is received, you will usually be sent a written acknowledgement.

When applying for Continous Applicant Pools, please check each vacancy for application instructions.

Appointees to the Senior Executive Service are offered an attractive remuneration package with salary sacrifice in return for optional benefits including.

AUTHORITY

Sections 168(1)(b)(iii) and 168(1)(n) of the Vocational Education, Training and Employment Act 2000

Regulation

Vocational Education, Training and Employment Regulation 2000, Part 3, Division 2, Sections 17-19

RESPONSIBILITY

A function of the Training and Employment Recognition Council (the council) under section 168(1)(c) of the Act is to regulate training contracts.

GUIDELINE

Description of Guideline

Apprentices and Trainees

- □ There must be a training plan for each apprentice or trainee. The training plan will be developed through negotiation by the employer, apprentice or trainee and the supervising registered training organisation (SRTO). The parties to the training plan must sign the completed training plan.
- \Box The training plan for an apprentice or trainee is a document containing prescribed information defined in section 13(1) of the Act. This prescribed information is:
 - the training to be delivered by the employer and, where it is agreed that training to be delivered by an SRTO, the training to be delivered by the SRTO
 - where there is training delivered by an SRTO, the training plan will state the maximum period the training will take
 - the qualification or statement of attainment (or completion certificate for callings where there is no corresponding course component) to be issued on completion of all the training in the training plan.
- □ In addition to the details described in section 13(1) of the Act the council may, from time to time, specify additional information regarding the training to be incorporated into the training plan.
- **D** The minimum information required in a training plan is:
 - name of qualification
 - the list of competencies to be undertaken

- the expected duration and expected completion the date of 0 apprenticeship or traineeship
- agreed method of delivery and release pattern to achieve an individual 0 competency
- where-ever a competency will be achieved totally in a simulated work environment, the training and assessment methodology must be negotiated during the development of the training plan and identified in the training plan
- specific start and end dates for completion, demonstration and \cap assessment of each competency both on and off the job
- competencies, competency groupings or competency weightings that set 0 out the expected progression through the qualification
- identified specific language, literacy, numeracy or disability support to 0 be delivered, if applicable
- o any identified current competency held by the individual or recognition of prior learning
- any alternative training arrangements (on and off the job) that may be 0 required to assist apprentices and trainees with special needs
- 0 assessment details, arrangements and responsibilities of the SRTO and the employer or workplace assessor
- monitoring/contact arrangements and obligations 0
- specific information on the employment and training schedule for school 0 based apprentices and trainees must be included in the training plan.

The parties to the training plan must comply with the training requirements specified in the signed training plan.
