Good afternoon colleagues,

Welcome to our first update for 2023.

This year will be very busy for the Justices of the Peace Branch (JP Branch) team as daily life becomes more familiar after three years impacted by the COVID-19 pandemic. We remain committed to all registered Justices of the Peace (JPs) and Commissioners for Declarations (Cdecs) through ongoing support.

# Clarification on Public Liability Insurance coverage for JPs and Cdecs

The JP Branch frequently receives enquiries from JPs and Cdecs around the state about insurance coverage while providing witnessing services to the public.

When performing official duties as a JP or Cdec for the State of Queensland, all JPs and Cdecs are covered for personal injury, public liability and professional indemnity insurance through the <u>Queensland Government</u> Insurance Fund (QGIF).

The QGIF policy protects JPs and Cdecs while they are witnessing anywhere in Queensland or Australia (regardless of whether it takes place in the JPs in the Community program, a private residence or workplace). In these cases, you should use the <u>Incident Report Form</u> to report the incident to the JP Branch.

Additionally, the Queensland Government Indemnity Guidelines apply to all registered JPs and Cdecs. According to the guidelines, volunteers offering their services on behalf of the state, cannot be personally held liable for any injury they may cause to a third party as long as they are acting in good faith. In this case, injury refers to monetary loss and good faith means they made an honest mistake on a client's form.

Under the guidelines, the Queensland Government accepts responsibility for and financial harm caused inadvertently. The purpose of this coverage is to ensure all JPs and Cdecs continue to provide an important service to the Queensland community.



#### Celebrating 20 years of the JPs in the Community Program



This year marks the 20<sup>th</sup> anniversary of the JPs in the Community Program (JPITCP) and JP Branch will host several events across the State to recognise, celebrate and promote the vital role that volunteer JPs and Cdecs play in their local communities. Further information will be released throughout the year.

To quantify the impact of a highly accessible and professional witnessing service, last year the 222 JPITCP locations witnessed over 1.86 million documents for over 624,000 clients, demonstrating the impact of a highly accessible and professional witnessing service.

Every one of these 222 locations are made up of a team of like-minded people who volunteer their time to assist the public with their witnessing needs. According to research, volunteering not only improves our health and happiness, by increasing wellbeing and relieving stress, but it is also a fantastic way to meet new people and create strong social connections (<u>Department of Health and Aged</u> Care, 2019).

Existing JPITCP participants frequently express their gratitude for the life-long friends and colleagues they have made, as well as numerous testimonials about their personal and professional growth.

#### After-hours JP search review

JP Branch is currently undertaking a review of the JPs and Cdecs listed on the <u>after-hours JP search</u> service on the Department of Justice and Attorney-General's website.

This review is focused on JPs and Cdecs to ensure details are correct and that they are still able to assist the community with their witnessing requests.

For any JPs or Cdecs not currently on the after-hours JP search, information will be sent on how you can list your details online.

No action is required until you receive an email with specific instructions.

## **Titles Queensland eConveyancing mandate**

From 20 February 2023, in accordance with the *Land Title Regulation 2022*, certain types of Qld Titles Registry documents must be lodged through an Electronic Lodgement Network (ELN).

This may result in a reduction of the number of physical Titles Registry forms that must be witnessed from this date. However, there may be times when a client requires their forms witnessed in person, in which case our standard witnessing procedure applies.
