- Shoes or sandals **NO** thongs
 - NO transparent clothing
- **DO NOT** wear clothing designed or altered to be of a revealing nature
 - NO singlets or tank tops
 - NO crop tops or bikini tops
- Clothing must be clean and in good condition
 - Clothing is **NOT** to display antidepartment slogans or obscene words, phases or diagrams.

If a visitor does not meet the appropriate standards of dress, he/she may be declined the visit.

Food

Baby food -Bottle formula and home prepared or canned baby food.

Property

ALL Hand Ins must have approval prior to being accepted into the centre.

VISITS PROCEDURE

Visitors must arrive ½ hour prior to the visit's session, Persons arriving after this time may not be permitted to visit.

Visitors will be given lockers prior to entering the visits area to secure wallets, mobile phones, valuables, medication and all personal items.

- Identification must be shown on each
- Visitors must remain in the visits area.
- Report to the visits officer when ready to depart. Locker keys and ID's will be issued on departure. Once visitors depart the visits area, re entry will not be permitted.
- Children must be fully supervised for the duration of the visit.
- Children are not permitted to remove shoes.

ARTICLES REQUIRING APPROVAL Medical Devices Medication

PROHIBITED ARTICLES

- False identification or passports
- Any acidic, caustic or flammable substance not lawfully issued.
- Security key, replica key, card or electronic device
 - Spirituous or fermented liquor
 - Drugs or medication not prescribed.
- Syringes or other device for the purpose of administering non prescribed drugs.
- All monies and credit cards, unless issued through the authorised trust account.
- Tattoo gun or device capable of changing the appearance of a prisoner or causing risk to his/her health.
- All other articles which may compromise the security of the Correctional Centre including cameras.
- Scanning devices and/or unauthorised communications devices
 - Mobile phones, Smart Watches
- Tobacco Product, Herbal Cigarettes or smoking related product including Smokeless Tobacco Product.
