Criminal history check

A criminal history check may be conducted for each
person named on the application form (eg. licensee,
permittee, nominee, company director, tour operator
or clergy).

A fee applies for each criminal history check required.

Should a criminal history check be required, an
officer of the Office of Liquor and Gaming Regulation
will contact you to obtain a photocopy of current
photographic identification, certified by a Justice of
the Peace, Commissioner for Declarations or police
officer as a true and correct copy. Acceptable forms of
identification include driver's licence or permit, Card
18+ or Proof of age card, Passport, Weapon's licence.
You may also be required to complete a Personal details
schedule for a Restricted area permit form.
