Open Data Release Schedule 2020 - 2021

Release schedule

The Department of State Development, Manufacturing, Infrastructure and Planning (DSDMIP) is committed to openness, transparency, accountability and active engagement with the community. This schedule underpins DSDMIP's Open Data Strategy 2020-2021.

DSDMIP's intent is to release information that does not have valid privacy concerns or an information security classification that would prevent its release. The identification of datasets to release will be informed by the ongoing review of the department's operations that generate information, and from public feedback and trends on the use and quality of previously released datasets. This information can then be reused and redistributed to anyone, anytime, and anywhere.

The schedule is summarised into three distinct categories:

- active released datasets are those that DSDMIP will be periodically updating so that the information is freely available to the public through the Queensland Government Open Data Portal
- inactive released datasets are those that DSDMIP will no longer be updating, but the information is still freely available to the public
- closed datasets are those that DSDMIP have determined as not suitable to be published on the Open Data Portal due to privacy, confidentiality or other reasons.

The Open Data Release Schedule will be reviewed and updated on an annual basis.

The Coordinator-General chooses the weight attributed to each of the above factors. The Coordinator-General is not bound to declare a project a coordinated project merely because it satisfies one or more of these characteristics. In making the declaration decision, the Coordinator-General must have regard to:- detailed information about the project given by the proponent in an initial advice statement- relevant planning schemes or policy frameworks of a local government, the State or the Commonwealth- relevant State policies and government priorities- a pre-feasibility assessment of the project, including how it satisfies an identified need or demand- the capacity of the proponent to undertake and complete the environmental impact statement (EIS) or impact assessment report (IAR) for the project- any other matter considered relevant.
