**DIRECTION TO THE BOARD OF THE  
QUEENSLAND BULK WATER SUPPLY AUTHORITY**

**Definitions and Interpretation**

1. In this Direction, these terms have the following meanings:

<b>Act</b>	<i>South East Queensland Water (Restructuring) Act 2007</i>
<b>Board</b>	the Board of Seqwater
<b>Department</b>	the Department of Regional Development, Manufacturing and Water
<b>Director-General</b>	the director-general of the Department and includes any person acting in that office from time to time
<b>Project</b>	the construction and commissioning of the Toowoomba to Warwick Raw Water Pipeline, including: <ul style="list-style-type: none"> <li>(a) raw water pipeline, connecting upstream from Mt Kynoch water treatment plant to the Warwick Reservoir;</li> <li>(b) Allora Pipeline connection – a separate pipeline and controls linking Allora borefield to the raw water pipeline;</li> <li>(c) Warwick Reservoir; and</li> <li>(d) all associated due diligence, project governance, project mobilisation, final design, approvals, land acquisitions, agreements, procurement, construction and commissioning activities.</li> </ul>
<b>Seqwater</b>	the Queensland Bulk Water Supply Authority (ABN 75 450 239 876)
<b>Pipeline</b>	Toowoomba to Warwick Raw Water Pipeline
<b>State</b>	the State of Queensland

2. A term used in this Direction which is not otherwise defined has the same meaning as that term is given in the Act.
3. Words in the singular include the plural and vice versa, unless the context otherwise requires.

**Direction**

4. In accordance with section 61 of the Act, we, the responsible Ministers of Seqwater, direct the Board to:
- a. do all things necessary to construct the Pipeline, Allora Pipeline connection and Warwick Reservoir by 31 March 2027, or amended by subsequent clarification, including additional investigative works to optimise the Pipeline design and route;
  - b. retain ownership of the constructed Pipeline;
  - c. operate the Pipeline and receive supply from the Allora Pipeline connection to supply raw water to Southern Downs Regional Council and Toowoomba Regional Council. This includes:
    - i. determining operating and maintenance arrangements;
    - ii. discounting the fixed bulk water charges on the water Seqwater will provide to Southern Downs Regional Council via the Pipeline in accordance with any future Community Service Obligation agreements with the State; and
    - iii. once pricing arrangements have been agreed with the Department and Queensland Treasury, recommend to the Minister for Regional Development and Manufacturing and Minister for Water the making of bulk water supply agreements (including for transportation) with:
      - A. Southern Downs Regional Council for the supply of water from Wivenhoe Dam;
      - B. Southern Downs Regional Council to facilitate the supply of water to Southern Downs Regional Council via the Pipeline; and

- C. Toowoomba Regional Council to facilitate the supply of water to Toowoomba Regional Council's four satellite communities of Cambooya, Greenmount, Nobby and Clifton via the Pipeline;
- d. deliver the Project's construction and commissioning consistent with Seqwater's Preparatory Works Handover Report for the Project provided to Government on 8 April 2022 in accordance with the Government's gazetted direction dated 24 May 2021 and any agreed design and route optimisation thereafter;
- e. once commissioned, transfer ownership and operation of the Warwick Reservoir and the Allora Pipeline connection (reservoir, transfer pump station and connection pipeline) to Southern Downs Regional Council;
- f. note that the Department will provide equity funding to Seqwater for project capital construction costs, with equity funding allocated to be recognised as an adjustment to contributed equity in the financial accounts of Seqwater and the Department;
- g. fund any Project capital costs in excess of equity funding that is provided by the State;
- h. obtain funding for any variations requested by the Toowoomba Regional Council or the Southern Downs Regional Council from that Council;
- i. not recover a return on or of Project capital construction costs from Southern Downs Regional Council and Toowoomba Regional Council;
- j. work collaboratively, with and assist where necessary, the Toowoomba Regional Council and Southern Downs Regional Council in the delivery of the Project;
- k. provide full cooperation and assistance to the State, the responsible Ministers and their respective advisors to implement this Direction;
- l. give effect to any written request of the Director-General, or a Departmental officer on the Director-General's behalf, for the purposes of this Direction;
- m. where there is an ambiguity or doubt about the meaning or intent of this Direction, Seqwater and the Board give effect to the interpretation of the Director-General as advised to them in a written clarifying statement.
