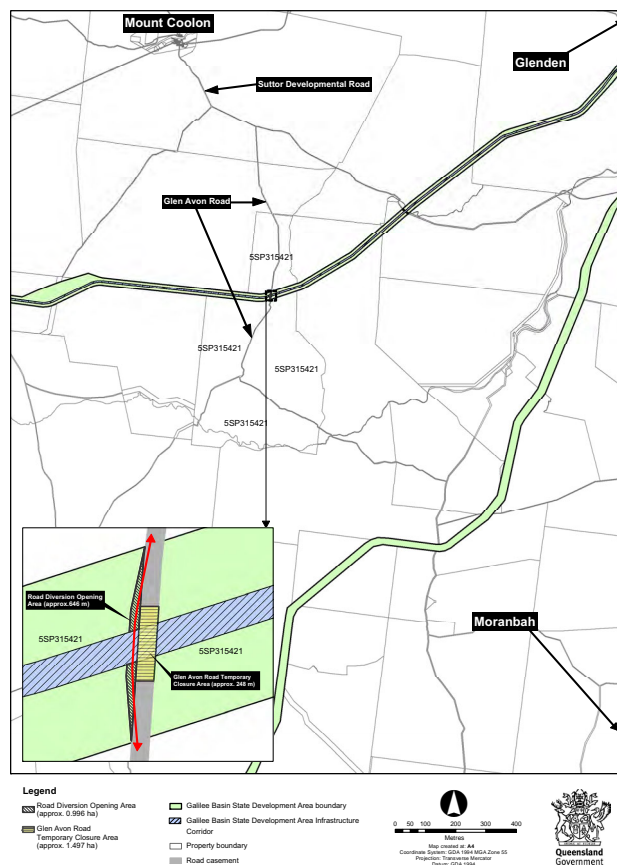

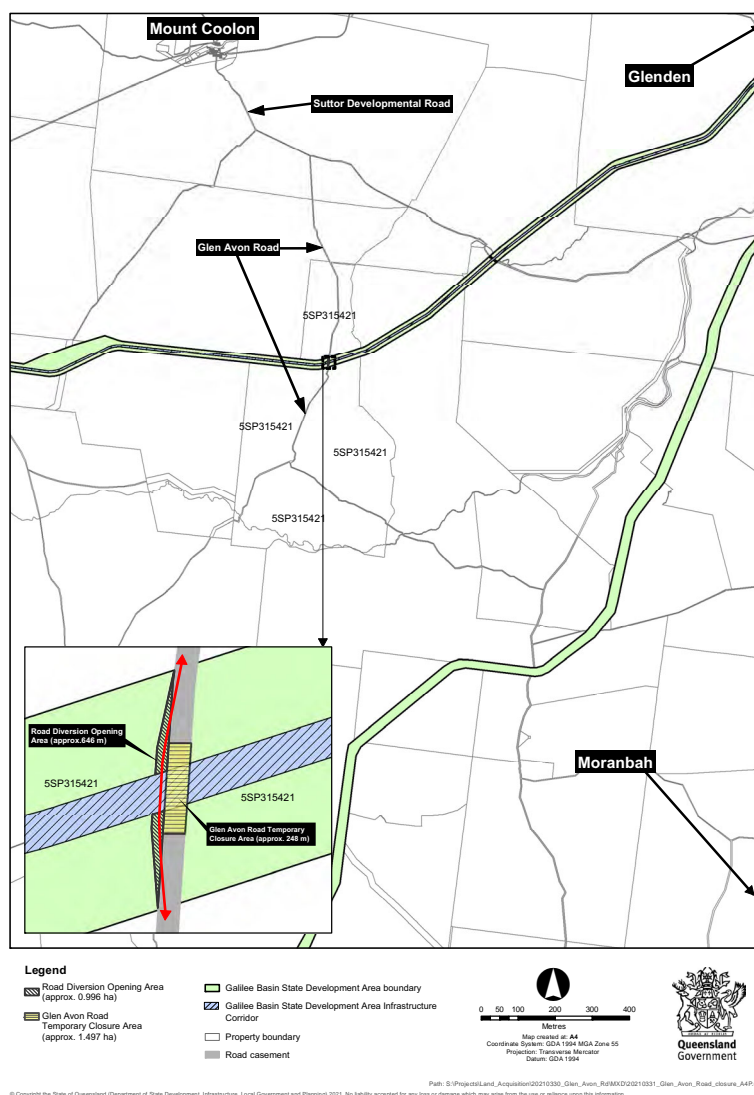

2. Queensland Bulk Water Supply Authority, trading as Seqwater, is directed to comply with this notice when charging rural irrigation water prices in Seqwater water supply schemes and distribution systems for 2021-22 to 2023-24.
3. The term “irrigation service” used in this direction has the meaning given to it under Schedule 4 of the *Water Act 2000*.
4. The term “water entitlement” used in this direction has the meaning given to it under Schedule 4 of the *Water Act 2000*, i.e. a water allocation, interim water allocation or water licence.

**Prices for rural irrigation customers in Seqwater bulk water supply schemes and distribution systems*****Bulk Water Supply Schemes***

5. For customers supplied by Seqwater bulk water supply schemes<sup>1</sup> that are receiving an irrigation service, the Part A and Part B prices set out in Schedule 1 are the Queensland Competition Authority’s final recommended prices<sup>2</sup> for 2020-21 to 2022-23 inclusive of a 15 per cent discount. For example, in 2021-22, a 15 per cent discount has been applied to the Queensland Competition Authority’s final recommended prices for 2020-21.
