TAKING OF EASEMENT NOTICE BY CAIRNS REGIONAL COUNCIL (No 01) 2022

GRANTEE'S RIGHTS AND OBLIGATIONS

The grantor grants to the grantee, in exchange for the consideration, an easement over the easement area for drainage purposes, and for such other purposes contemplated by the terms of this easement including for the installation of the works. **Grantee's rights and obligations**

- a) dispose of the unauthorised improvements and any demolition material in any way the grantee deems fit without being liable to account to the grantor; and
- b) the grantee may recover from the grantor including by the commencement of legal proceedings, the costs of such removal including any other costs it has incurred in the disposal of the unauthorised improvements.

5. DEFAULT

5.1 Remedies

Subject to clause 5.2, if a party to this easement is in default of its obligations under it, and that default is not remedied within a reasonable time after written notice from the other party specifying (in reasonable detail) the default, the non-defaulting party may, at its election:

 a) do anything that is reasonably necessary to correct the default; and b) recover from the defaulting party, the costs which it reasonably and properly incurs in doing so.

Emergency action

In cases of emergency or where there is a likelihood that a failure to act promptly will result in imminent injury, damage or loss to any person or property, the non-defaulting party is entitled to exercise the rights in clauses 5.1 a) and b) without first having given a notice and opportunity to remedy the default in accordance with that clause.

No liability

To avoid doubt, a party which properly exercises its rights under clause 5.1 or clause 5.2 does not incur liability to the other party merely by reason of doing so.

Ancillary rights

To avoid doubt, a party exercising its rights under clause 5.1 or clause 5.2 may enter upon and bring equipment onto the land and carry out work as may be reasonably required to correct the default. **DISPUTE RESOLUTION**

- a) If a dispute arises in connection with this easement, then a party may only deal with that dispute in the manner set out in this clause.
- A party to a dispute which arises in connection with this easement may give to the other party or parties to the dispute a notice specifying the dispute and requiring its resolution under this clause.
- c) Within 14 days after a notice is given (or such longer period as is agreed in writing by the parties to the dispute) each party to the dispute must use its best efforts to resolve the dispute in good faith.
- d) If despite the parties' best efforts the dispute is not resolved within 14 days after notice a party may by notice to the other party or parties to the dispute, refer the dispute to be determined by a Queensland Law Society approved mediator appointed by agreement between the parties or failing agreement, by the president of the Queensland Law Society at the request of the grantor or grantee.
- e) If the dispute is not resolved within 28 days after the appointment of the mediator, either party may commence legal proceedings to resolve the dispute.
- f) The cost of the mediator will be borne equally by the grantor and grantee.
- g) The provision of this clause does not prevent any party from obtaining any injunctive, declaratory or other interlocutory relief from a Court which may be urgently required.

- c) on the day it is emailed (if sent by email), provided that the sender of the email does not receive any notification of a failed transmission.

7.12 Governing law

This easement is governed by and shall be construed in accordance with the laws of Queensland and applicable statutes.
