- · You will be required to take another oath or affirmation of allegiance of office.
- · After registration you will receive a certificate and seal. If you are currently a JP(C.dec), you will also receive a registered number

· It is essential that you notify the Registrar of Justices of the Peace and Commissioners for Declarations of any changes of address within 30 days.
